information charge was mailed to me from John, when he was transferred to Santa Rosa.

2.) The second information charge was fax to me by Kevin Holtz, John's public attorney of appeal (former attorney). This information charge has attached to it a fax coversheet included, dated 9/26/08, To: Celeste Solba, re. pages 6, From: Kevin Holtz, comments: This is coversheet for signed information that I sent to you, the top heading of the fax front coversheet page has Law Office of Public Defender, Seventh Judicial Circuit, Flagler, Putnam, St. Johns + Volusia Counties, James S. Lundy, Public Defender, Craig S. Hyer, Chief assistant.

On page 2 of 5 pages John's physical description, age, date of birth, social security no. is not on it).

On page 5 of 5 pages, a notary public stamp with her signature and date, the signature over the Designated Assistant State Attorney is unclear, it also has the number 906557, on the bottom of the unclear signature. The only stamp logo symbol appears on the front upper left side of the fax coversheet page, the stamp of Lydia Gardner is not on the information charge and none of the five (5) information charge including the front fax coversheet has

a fax address on the top of each page as required by Federal Law.
