

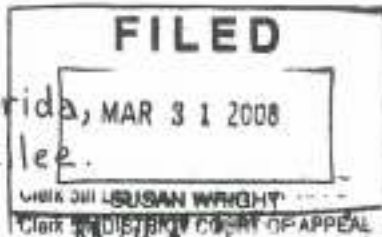

Motion to supplement the record

Comes now, the Appellant, John Dobbs, to supplement the record, before this Honorable Court. The Appellant asserts the following police statements, which are titled as Transcripts of taped interviews conducted by detectives, to be essential to the process of formulating an accurate pro se initial brief, for review before this Honorable Court, as the police statements are referred to throughout the trial and sentencing proceedings, and yet are not provided in the index of record. Pursuant to Rule 9.200(e) Fla.R. Appellant Procedure.

The Appellant, John Dobbs, received the following police transcripts in his discovery, delivered to him by his trial public defender, Ms. Catherin Chien, mid December 2006, immediately after they were provide by the state. The following are referred to by both the defense and state prosecuting attorneys as well as Mr. Dobbs, during both trial and sentencing proceedings:

Note: You may find the references to these statements to police on the following pages: Phillip Westfall trial transcript p.303, Deanna Washington trial transcript p.562, Andre Blanco & Francisco Gotay sentencing transcript p.31, Justin Idle sentencing transcript p.30, Hanzel Holiday trial transcript p.441, Leonard Bolanos records p.188 (state witness list). These transcripts are referred to as "PS" and are distinguishable by their first and last initials in the appellants pro se initial brief.

Also the Appellant has resubmitted a copy of the original charge information filed (which he recieved unsigned and lacking certification of oath, mid December 2006 with the above mentioned transcripts and the rest of his discovery) via Celeste Dobbs, and request that it is recognized

by this Honorable Court; as it is a topic argued in the Appellants coming Prose initial Brief. It is referred to as "IF" pages 1 thru 5.

The Appellant, does possess his own personal copies of the above mentioned transcripts, and thus is providing this Honorable Court with copies of these police statements which were given to detectives by these witnesses the night of the incident, as they are reflected on the face of the trial court record, yet have not been produced or provided (according to the index of record in the Appellants possession) to the Fifth District Court of Appeal. These copies are accurate, but with the addition of personal notes being they are the Appellants personal copies (please excuse), yet they are reliable; since they are signed by the interviewing detectives. It may please the court, to have a thorough trial court record available for its review. Thank you.
