

Dear Mom,

9/23/09 - 9/26/09

I hope this letter finds you in good health and circumstances that benefit you. As you know I am in confinement and have been since 9/11/09. I am just getting around to writing you because they refused to give me a pen and as of yet have not allowed me to order one. Yesterday, I found one officer who was kind enough. I did get your letter with the 4 different graphs called Usage summary for American me King universal.org, and I understand your confusion. Graph #'s 2 and 3 show that the website has been hit over 50,000 times (50,951 by September 7<sup>th</sup> 2009 and 54,045 by September 13<sup>th</sup> 2009) since it went up in July, and graphs # 1 and 4 show that it was hit less than 9,000 times (7,535 by September 5<sup>th</sup> 2009 and 8,154 by September 13<sup>th</sup> 2009), obviously at least 2 of them are false. Considering its promotion by XXL magazine (Do you want to ride) and your consistent E-mailing efforts; numbers 1 and 4 are highly unlikely, especially with friends and both sides of the family, with numerous colleges; promoting as well.

I spoke with a computer specialist whose family has been in the programming business for years and he verified what the political activist in New York told you; that someone on the other side appears to have connections with some sort of intelligence agency. He said that assuming that any of the 4 graphs are nearly correct, it is impossible in today's world that only 2 or 3 people would E-mail you in regards to the site even if you had less than 300 visitors. He told me that the 5<sup>th</sup> DCA or Public Defenders Office creating a site regarding my case and posting it next to yours is basically unheard of and only shows their guilty conscience. He also said, about the website you had Anthony start, but told him to take off line because of his family emergency, which made him take too long to correct

and complete ([americanmekinguniversal.com](http://americanmekinguniversal.com) instead of [.org](http://americanmekinguniversal.org)); being promoted by their website; that they are clearly trying to confuse anyone who is seriously interested and separate the hits. I told him about the E-mail address appearing to be rerouted to another man's information (the 31 year old white man also named John Dobbs living in Mexico) and he flipped. He said that they were really trying to screw me, and that the odds that after all this time and all the hits; that the pal pay donations read "It's obvious that there is some well funded effort to prevent you from receiving any help. He said that's why they would also want to keep the number of hits appearing low so that no pro bono attorneys or active politicians would feel so inclined to show their support for lack of publicity.

My advice is to take down the pal pay so noones money is rerouted or whatever to the wrong cause and stick to the P.O. Box. You'll just have to check the post office more often.

I am sorry you have to go through all of this. This is crazy. I believe that William Troy has family members belonging to some sort of secret society or something as well as the government; but as long as we keep fighting all we have to do is win once with the truth and they have to win a thousand times with corruption. Please don't stress yourself out; and look at it as a game. They really want to break us spiritually and mentally to make us physically weak. Stay strong some officials won't stand for this abuse of power.

Oh yeah let me tell why I'm in confinement! As you know I am constantly being set up and thrown in confinement when things start to get hot with my case, I guess that's why

they moved me back to the East unit for no reason after moving me to the West Unit for over a year. Now a week and a half later they set me up again. Things that make you go hum? This time they call themselves being slick bringing a bunch of blank witnesses statements to the hearing, yet still the majority of the evidence was on my side, but of course they found me guilty based on the officers statement all alone. I first plead exemption for 2 reasons: 1) I was told that these hearings were not criminal and therefore must be administrative civil proceedings, being that I am bankrupt I am entitled to that plea and 2) I am entitled under the American disability act if I had refused because I am able to show the injury which I complained of. They refused to take my plea and said they never heard of it (they being team chairman classification officer Jarvis Jackson and lieutenant Alfred Rogers) even after I showed them the burned whole in my ankle.

So here is how it went: They move me over here to the East Unit out of the blue. There were no security changes or complaints which affected my status. One week later they assigned me to officer Hollister's inside grounds work crew. Mind you I have been working inside grounds for the entire 2 years that I have been at Apalachee Correctional Institution, and all of my performance evaluations have rated above satisfactory regarding work and study habits. Ironically even my 9/15/09 evaluation which is 4 days after this occurred (I'm mailing that copy with this letter). I was told officer Hollister likes to work the hell out of his crew, and recently my ankle has been getting worse to the point where the pain might take months to get rid of, its actually I believe what they call a tendon which ~~connects~~ <sup>connects</sup> to the heel. So I spoke to Captain Loper who told me to apply for a job change after I showed him my injury. On 9/10/09 (Christal's birthday I mailed

a request for a job change explaining my situation and how the other inside grounds supervisors I had work for showed lenience, but things had gotten worse. I toughed it out for years but Im 35 years old now and if I stay on it for to long soon I have to sit. Its been 2 weeks and I havent recieved a response. On 9/11/09 I went to work around 8 am. I showed officer Hollister my injury and told him about my request; he said he wanted to see how I work. I worked till after lunch when my ankle started hurting like crazy. He said we'd be finished in a few minutes but if I couldn't continue, to declare a medical emergency. I went to medical and they never even examined it. Nurse Vance laughed at me and told me I must be rich to throw my money away, visiting medical. She took my weight and my temperature and ignored my complaints. I checked in at 12:22 and out at 12:30. I was sent back to work. When I got back to officer Hollister he had everyone's equipment ready to be checked in storage and we were done. I told him what happened and he locked me up.

(My pen stopped writing and I did not get one until today 9/26/09. Inbetween someone got stabbed in the neck on the rec yard and I have been tranfered to another prison on 9/24/09. I am currently in confinement at Liberty Correctional Institution Dorm I wing 2 cell 116 Lower bunk.

The possibility that this is a better camp is enough to be thankful for but I really believe I need to be tranfered out of region 1 and region 2 where I was told by the captain he had enough pull to make my life hell.)

Anyway I was given a D.R. for refusing to work, and sentenced to 60 days D.C. confinement not including the 7 I already did. Officer Hollister said the incident occurred at 1:15 pm, yet I was locked up around 12:45 pm. Either way I obviously worked

all day until I couldn't anymore. I believe I was set up so that I could not contact you or work on my legal work, since time is running out for my federal habeas corpus.

I asked in my statement that they take a photo of my ankle as proof but they refused. More proof of the set up is that I filled out a request for sick call to document and get special passes based on my injury and was placed on the call out for the morning. I started this letter 9/23/09. I was pulled out of Q 3116L <sup>between</sup> ~~around~~ 9:00 am and 9:30 am (should be on camera). And when I got to medical none other than Nurse Vance turns me away saying that they left a note not to see me until after my 60 days in confinement. This is why they'll have no findings from examining my injury. They don't want me to be able to use it to appeal my D.R. I have 15 days from 9/17/09.

Now I am at liberty and I have not gotten a pillow or sheets yet (2 days) and my new sick call request was ignored this morning. I am hoping these are just honest mistakes, and not plans to torture me. I hope these officers don't set me up with D.R.s like my last two camps (A.C.I. and Gulf C.I.)

Still no reason to upset yourself. I'm a warrior, and this is all to keep record. I know you'll probably want to post this on the site, if you do call it recent update.

P.S. Officer Hall who served my D.R. to me told me to stop writing when I was writing my statement because I was taking too long and said she doesn't care if I grieved it or told the president on 9/16/09. Inmate Rob Hinson DC# B-221219 is a witness.
