| 3 | THE COURT: We have all of our jurors. Let the |
| 4 | record reflect that counsel for each party is present |
| 5 | as is the defendant as he has been throughout. |
| 6 | State, do you recognize the presence of the jury |
| 7 | selected to try this matter? |
| 8 | MS. LASKOFF: Yes, Your Honor. |
| 9 | THE COURT: Defense, do you? |
| 10 | MS. CHIEN: Yes, Your Honor. |
| 11 | THE COURT: Ladies and gentlemen, I apologize for |
| 12 | the late start. I do typically like to start on time |
| 13 | but the other matter that I was handling deserved a |
| 14 | full and uninterrupted hearing this morning. |
| 15 | State, you may call your next witness. |
| 16 | MS. BARRA: Thank you, Your Honor. At this time |
| 17 | the State calls Justin Idle. |
| 18 | Thereupon, |
| 19 | JUSTIN IDLE |
| 20 | was called as a witness and, having first been duly sworn, |
| 21 | testified as follows: |
| 22 | MS. BARRA: May it please the Court. |
| 23 | THE COURT: You may inquire. |
| 24 | MS. BARRA: Thank you, Your Honor. |
| 25 | DIRECT EXAMINATION |

- 1 BY MS. BARRA:
- 2 Q Good morning, sir.
- 3 A Morning.
- 4 Q Could you please state your name and spell your
- 5 last name.
- 6 A Justin Idle, I-D-L-E.
- 7 **Q** Mr. Idle, on October 25th, 2006, where were you
- 8 employed?
- 9 A Dollhouse.
- 10 **Q** And what was your title and your duties on that
- 11 day?
- 12 As a floor man we have a lot of duties to keep the
- 13 girls secure. Also clear the parking lot at the end of the
- 14 evening, keep the floors clean.
- 15 **Q** When you clear the parking lot at the end of the
- 16 evening, does this happen right after the lights come on?
- 17 **A** Yes.
- 18 **Q** And do you usher everybody out?
- 19 **A** Yes.
- 20 On that night on October 25th, 2006, do you recall
- 21 who, what individuals were kind of last to leave on that
- 22 occasion?
- 23 **A** There was actually a lot of individuals asked to
- 24 leave. Every time we close at the end of the evening there
- is always a bunch of people that try to stay later so we

- 1 have to usher everybody out at the same time.
- 2 **Q** And is that what occurred on that day that night,
- 3 early morning?
- 4 A Yes.
- 5 **Q** When you got out in the parking lot, what are your
- 6 duties once you're in the parking lot and once everybody is
- 7 out of the club?
- 8 A Once everybody is out of the building, we actually
- 9 walk around the entire parking lot to make sure there is
- 10 nobody inside any vehicles.
- 11 **Q** And why do you do that?
- 12 **A** That way nobody can come up and run up and injure
- one of the girls or injure one of us behind our back or
- 14 anything.
- 15 **Q** When you were doing that, did you notice
- 16 individuals in their vehicle?
- 17 **A** On that evening?
- 18 **Q** Yes.
- 19 **A** No.
- 20 **Q** Did anything unusual happen that evening?
- 21 **A** Later that evening, yes.
- 22 Q Okay. That is what we were are getting at. Later
- that evening, what kind of caught your attention?
- As I walked out and I walked around the parking
- 25 lot and I came in between two vehicles, there was -- started

- 1 some words being said back and forth.
- 2 **Q** Words between who?
- 3 A Actually I don't know. Are they here? There was
- 4 four gentlemen in one vehicle and then there was a gentleman
- 5 and a lady in the other vehicle.
- 6 Q Okay. Just for identification purposes, the four
- 7 gentlemen in one vehicle, what was their nationality or
- 8 their race?
- 9 **A** I really don't know.
- 10 **Q** Okay.
- 11 **A** Yeah.
- 12 **Q** And you said that there was a gentleman and a
- 13 woman in another vehicle?
- 14 **A** Uh-huh.
- Do you know what that vehicle was that they were
- 16 in?
- 17 A No, I do not. It was just -- it was a light
- 18 colored car is all I remember.
- 19 And there were words going back and forth. Were
- 20 the words going back and forth between all four of the
- 21 gentlemen who were in one party or did it seem --
- 22 **A** It seemed like maybe one or two of the individuals
- 23 said something in regards to the gentleman had to walk out
- 24 with security because he was a pussy is all I can really
- 25 recall is what was said.

- 1 Q So they were -- members of the group of four were
- 2 saying something to the other gentleman regarding that they
- 3 had, that that gentleman had to walk out with security?
- 4 A Yes.
- 5 Are you in a security type clothes or does
- 6 anything say security on it?
- 7 A No, tuxedo.
- 8 Okay. But I guess people just assumed that you
- 9 were security?
- 10 A Yes. They assume you are the bouncer there.
- Okay. So what was his response to them saying
- 12 that to him?
- 13 A Umm, he said he doesn't need anybody to back him
- 14 up.
- 15 Where is he when he is saying that?
- 16 A He's standing at the driver's side of the door at
- 17 his vehicle. The door is open and he's standing right at
- 18 the driver's side.
- 19 **Q** Now, prior to this taking place, had you told him
- 20 to leave the area?
- 21 **A** Every time we walk out of the building we say,
- 22 okay, we need everybody to leave the parking lot.
- 23 And is that like a group yell to the whole lot?
- 24 **A** That is just, yeah, that's the first time we say
- 25 something.

- 1 **Q** What was the second time or if any time did you 2 tell that particular person to leave?
- A the point when I walked around the vehicles and
- 4 I came up in between the vehicles and the gentleman was
- 5 standing there and they were yelling back and forth, I again
- 6 said, okay, we need everybody off the lot. Then when they
- 7 started yelling, I said okay, this isn't gonna happen here,
- 8 and for the third time I told them they have to leave the
- 9 lot.

- 10 **Q** The third time that you told them, is that the
- 11 time where he was standing in the door?
- 12 A Yes.
- 13 **Q** Of his vehicle?
- 14 A Yes.
- 15 **Q** And how close were you to him when you told him to
- 16 get off the lot?
- 17 **A** I was about one parking space away from the
- 18 passenger side of his vehicle.
- 19 **Q** Did you yell it at him?
- 20 **A** No.
- 21 **Q** Did he give you any indication that he had heard
- 22 you?
- 23 **A** Umm, no, didn't acknowledge me really.
- 24 What happened next, did he get into his vehicle?
- 25 A No. He -- from what I remember, he stood there

- 1 beside his vehicle then the, some of the other gentlemen
- 2 began to continue yelling. I can't recall what they were
- 3 yelling but slowly walked toward his vehicle. Then it
- 4 looked like there was going to be a fight, so I told my
- 5 security, my other security guy Leo to go call police, at
- 6 which time when I turned back around, they were fist
- 7 fighting.
- 8 Q Did it appear that all four of those individuals
- 9 were going, moving towards him?
- 10 A At least three of them.
- 11 **Q** At what point did you turn your head? How close
- were the people to each other?
- 13 A Still like at least four parking spaces away.
- 14 **Q** So they are four parking spots away. You turn
- 15 your head. When you look back, people are fighting?
- 16 A Yes.
- 17 **Q** And who, or I guess how many did you see fighting?
- 18 At the beginning I only saw the two. One, the
- 19 gentleman, Mr. Dobbs, and as well as one of the other
- 20 gentlemen. I can't recall which one.
- 21 **Q** What were the other gentlemen doing, the other
- three doing when just these two were fighting?
- 23 **A** They -- when I turned around, the first two
- 24 gentlemen were in a fight. They were continuing to walk
- 25 toward him. That was it. And they were saying something.

- 1 I don't recall.
- 2 Q Okay. Now, at any occasion did -- now, right now
- 3 we have two people fighting?
- 4 A Uh-huh.
- 5 **Q** Any occasion did somebody else join the fight?
- 6 **A** Not that I recall.
- 7 **Q** That you saw?
- 8 A Not that I recall.
- 9 What was the next thing that you recall happening?
- 10 **A** When they -- when I turned around and saw them
- 11 fighting, I tried to yell to get them to stop at which time
- 12 they weren't stopping, so I proceeded to run in and I had --
- 13 I turned around to look to see if Leo, my security guard was
- 14 inside yet and then I believe I turned around again and then
- one of the gentlemen was hitting one of the other gentlemen
- 16 with something, and then I believe at that point one of the
- 17 guys were injured.
- 18 **Q** Okay.
- 19 **A** There was a cut on somebody's face. They were
- 20 cut, obviously, with -- some sharp instrument was being used
- 21 to injure the four gentlemen. At which time everybody was
- 22 involved.
- 23 **Q** I am gonna kind of slow you down with exactly what
- 24 you just said. Now you see there are two guys fighting.
- 25 You yell at them and say break it up?

- 1 **A** Yep.
- 2 Q And then it becomes clear to you that they are not
- 3 breaking it up?
- 4 A Yes.
- 5 Q So at that point that's when you turn to go
- 6 inside?
- 7 A Yes.
- 9 A No. At that point I did not.
- 10 Q Okay. How long do you think your back was turned
- 11 to the fight when it was happening between the two guys?
- 12 A I couldn't tell you. It was a very brief period
- of time, maybe, you know, ten seconds, 15 seconds, something
- 14 like that. Just to kind of look around and see what was
- 15 going on outside, other than what they were doing.
- 16 **Q** And then when you turned back around, were -- what
- 17 did you see then?
- 18 **A** Umm, that's when everybody was kind of gathered
- 19 around the fight, and then that is at the point where he was
- 20 hitting them with something.
- 21 **Q** When you say he, you are referring to which
- 22 person?
- 23 A Mr. Dobbs, I believe.
- 24 Q Okay. Would you be able to recognize Mr. Dobbs if
- 25 you saw him again?

- 1 A Probably not.
- 2 Q How do you know that it was Mr. Dobbs?
- 3 A It was the gentleman that was in the vehicle. I
- 4 don't know if that's exactly who he is or not. It is the
- 5 gentleman that was in the vehicle with the girl.
- 6 Q Okay. So the person who you believe is Mr. Dobbs
- 7 was hitting them with something?
- 8 A Yes.
- 9 Q Could you tell what that was?
- 10 A No. Never could see it.
- 11 Where was the object that he was hitting them
- 12 with?
- 13 A It was inside of his hand but I could not see
- 14 exactly, you know, what it was or what it consisted of.
- Describe the manner in which he held his hand.
- 16 A His hand was closed. He was closed fisted and
- 17 whenever he would -- I recall when he had came up and
- 18 attacked one of the gentlemen, he had actually put his hand
- 19 around him into his chest and then hit him this way, flat
- 20 handed into his chest.
- 21 **Q** So a sideways hit like this?
- 22 A Yes. Yes.
- 23 **Q** Rather than straight on?
- 24 **A** Yes.
- 25 Q Could you tell if that had caused any damage to

- 1 the person that he had hit?
- 2 A Just after he had moved back, the gentleman had
- 3 grabbed his chest and began to stumble. That is all. At
- 4 that point I knew something was a lot more intense than what
- 5 we were -- than it was a fist fight, so I ran inside at that
- 6 point to get the police.
- 7 **Q** Now, at this point where there was -- did you see
- 8 blood at that point?
- 9 A I believe one of the gentlemen's face was cut at
- 10 that point, yes, but I didn't see that actually happen.
- 11 **Q** All right. At this point right here, is it still
- 12 one-on-one?
- 13 A No. It was more of a group, like, at that point.
- 14 They were surrounding the individual and everybody was
- 15 trying to, you know, stop him from doing this.
- Now, you said that they were trying to stop him
- 17 from doing this. Why do you say that that's what they were
- 18 trying to do?
- 19 MS. VICKERS: I'm gonna object. This is
- 20 speculation.
- 21 **THE COURT:** Overruled. If he can testify from his
- 22 own observations.
- 23 **THE WITNESS:** Umm, that he, umm -- I can't really
- say that they were trying to stop the individual from
- 25 doing harm. I know that they were just trying to -- it

- was still a fight and they were trying to basically,
- 2 you know, win I guess.
- 3 BY MS. BARRA:
- 4 Q Okay. So at this point they start engaging in
- 5 this guy?
- 6 A Yes. And everybody was taking shots at the
- 7 gentleman.
- 8 Q Did you see anybody hit the gentleman?
- 9 A I saw one of the four individuals actually, when
- 10 they were surrounding, one of them snuck up behind him and
- 11 actually hit him in the throat, you know, with his hand, but
- 12 I can't recall. He wasn't using any weapon that I saw. It
- 13 was just his hand. It wasn't like a punch.
- 14 Can you recall if that caused any blood on the --
- 15 **A** Not that I recall. No.
- 16 **Q** When that individual got involved with the fight,
- 17 was it after there was blood on the other guy?
- 18 **A** One of the other gentlemen at that point had
- 19 already had blood on him, yes.
- 20 **Q** And where was -- you indicated earlier that he had
- 21 hit somebody from behind and made kind of like a slashing
- 22 motion on that individual. Where did he go, was he still
- 23 involved in this fight?
- A Umm, at that point he was kind of stumbling
- 25 around. He was stumbling around holding on to his chest.

- 1 He really wasn't that coherent.
- 2 Q And is that the time when the other people jumped
- 3 into the fight?
- 4 Yes. It was never like everybody just like jumped
- 5 on top of him and everybody was surrounding him and each guy
- 6 was taking a shot at him trying to stop it.
- 8 Mr. Dobbs?
- At the same time, not that I saw.
- 10 **Q** What happened next?
- 11 **A** I had ran inside at that point to make sure the
- 12 police were being called. At that point I had met up with
- 13 Leo at the front door, and I had ran inside and I told the
- 14 management what was going on and he had to get the police
- 15 out there. They still weren't aware of what was going on at
- 16 this point.
- 17 When you came back outside from doing that, what
- 18 was the scene like then? Was there still a fight going on?
- 19 A No, actually everybody had fled the scene, but the
- 20 one gentleman was still like kind of staggering around and I
- 21 believe he fell on one of his other friends, but Mr. Dobbs,
- 22 I believe, and the girl had already fled the scene.
- 23 **Q** So when you said everyone fled the scene, it was
- 24 Mr. Dobbs and the female?
- 25 **A** Yes. Yes.

- 1 Q And then the four other guys, were they still
- 2 there on scene?
- 3 A Yes.
- 4 Q Do you recall how long it took for the police to
- 5 arrive from --
- 6 **A** No.
- 7 Then you initially saw what was going on?
- 8 A Yeah, I really can't recall how long the time
- 9 frame that was involved.
- 10 **Q** When you went back out there, what did you do?
- 11 A At that point I had kneeled down to -- he was
- 12 laying on the ground at that point so his shirt was then
- 13 opened. I had waved one of the other gentlemen to open up
- 14 his shirt and there was somebody helping us at that point.
- 15 I do remember who the gentleman was, and he was basically
- 16 laying on the ground dying. So I ran inside once again to
- 17 get some water and then I brought out some water and some,
- 18 you know, large bar towels to kind of clean him up and see
- 19 what was happening. Then the guy that was helping us at
- 20 that point and I were rubbing his cheeks. He said he needed
- 21 more water, so I ran in and went to get more water and by
- that time when I came back out, that's when the paramedics
- 23 were there.
- 24 Prior to the paramedics arriving, could you see
- 25 the wounds that were on him?

- 1 A Not clearly. There was a lot of blood.
- 2 **Q** And once the paramedics arrived, did they pretty
- 3 much take over everything and that was that?
- 4 A Yes.
- 5 MS. BARRA: Thank you, Your Honor. May I have a
- 6 moment?
- 7 **THE COURT:** You may.
- 8 BY MS. BARRA:
- 9 Sir, just a couple other questions. At any point
- 10 did you see the defendant display a weapon?
- 11 A Mr. Dobbs? No, I did not see him display a
- 12 weapon, not that I could see as a weapon.
- 13 **Q** Did he ever say anything in regards to back off, I
- 14 have a knife, or anything like that?
- 15 **A** Not that I recall.
- 16 **Q** Okay.
- 17 MS. BARRA: Thank you. I have no further
- 18 questions.
- 19 **THE COURT:** Cross-examination?
- 20 MS. VICKERS: Thank you.
- 21 CROSS-EXAMINATION
- 22 BY MS. VICKERS:
- 23 Q Good morning, Mr. Idle.
- 24 A Good morning.
- 25 **Q** How are you?

- 1 A Good.
- 3 of sight to you. Mr. Idle, I want to ask you some questions
- 4 about the setup of the parking lot and where the cars were,
- 5 and where the fight took place. If I showed you a picture
- of that, would that assist you in explaining to the jury
- 7 where everything was?
- 8 A Yes.
- 9 MS. VICKERS: May I approach?
- 10 BY MS. VICKERS:
- 11 **Q** Now, if for any reason you can't see this, because
- 12 I need to make sure the jury can see it, you can step down
- 13 and we can talk about it. I don't know if everybody on the
- 14 jury can see that. Is it easier if you step down?
- 15 **A** I can lean up here.
- 16 **Q** That's fine. Now, when you were walking out of
- 17 the club, you weren't specifically ushering anyone out, were
- 18 you?
- 19 **A** No.
- 20 **Q** You are just trying to say everybody get in your
- 21 car?
- 22 **A** Yes.
- 23 **Q** And to your knowledge, there were no problems
- 24 inside the club?
- 25 **A** No.

- 1 Q All right. Now, when you walk out from the club,
- 2 did you notice where the group of four men -- where were
- 3 they headed?
- 4 Mell, everybody -- when we walk outside the club,
- 5 you can't see it in this picture, but the entrance to the
- 6 club is back this way. That's actually the corner of the
- 7 building in the back.
- 8 **Q** Okay.
- 9 A Everybody kind of generally walks in between the
- 10 building and there's like a median out there.
- 11 **Q** Is that where the canopy is?
- 12 A Yes, the canopy is. And everybody generally walks
- 13 between the building and that. When they walk out towards
- 14 the parking lot, we walk around the other side and walk
- 15 around the vehicles because there's another parking lot on
- 16 the other side of that median. So we make sure that there
- 17 is nobody in any of those vehicles.
- 18 **Q** Now, the canopy, it is not fully covered, is it?
- 19 A No, just the top.
- 20 **Q** So you are able to see through?
- 21 **A** You can see there's a gate around it, but you can
- 22 see through it.
- 23 **Q** It is like a short wrought iron gate?
- 24 **A** Yes.
- 25 **Q** Now, in the bottom picture, this would be like --

- the club would be back this way, and the canopy would be off
- 2 this way?
- 3 A The club would be on this side right here. This
- 4 is the club, so everybody generally walks out this
- 5 direction.
- 6 Q Okay. Straight out through here and for the
- 7 record, I am --
- 8 A Yes, because where these lines end is actually
- 9 where our entrance canopy to the club is.
- 10 **Q** Okay.
- 11 **A** So they walk --
- 12 **Q** From left to right?
- 13 A They would actually walk right when they get to
- 14 the end of the little canopy.
- 15 **Q** And is that -- do you know would that be west,
- 16 north, south, east?
- 17 **A** I believe it would be west.
- 18 **Q** Okay. So, do you know which -- could you tell
- 19 where the group of four were headed as they are walking out?
- 20 A Their vehicle was parked out in this area. I
- 21 don't remember exactly which.
- 22 **Q** Kind of like adjacent to the club?
- 23 A Yes, pretty much to the adjacent to the rear of
- 24 the club.
- 25 **Q** So if they had walked straight out through the

- 1 route that you say everybody walks, their vehicle would be
- 2 --
- 3 A Out in that area.
- Q Out in this area? Okay. Near across from where
- 5 the orange cone is in that picture?
- A Yes, roughly behind that, somewhere in that area.
- 7 Q And the black male and black female, did you see
- 8 which direction they were headed?
- 9 A Generally walked out in the same direction because
- 10 the valet stands on the other side of that, on the side of
- 11 that median, so --
- 12 **Q** Did you see where their car was parked?
- 13 A that point I didn't know where their car was or
- 14 if it was their car.
- 15 **Q** When you saw them by the car, where was the car?
- 16 A Their car was parked roughly on the other side of
- 17 the median, but back here in this line, like right by that
- 18 median there. Maybe two parking spots in.
- 19 **Q** So over here?
- 20 **A** Yes.
- 21 **Q** So the black male and black female's car would
- 22 have been right over here?
- 23 **A** Yes.
- 24 **Q** And the group of four males car would have been
- 25 over here?

- 1 A Yes.
- 2 Q Okay. You can sit down for a minute. Now, if the
- 3 black male and the black female had gotten in the car and
- 4 left and kind of did a circle and drove back around, would
- 5 you have seen that happen?
- A It is likely I would have saw it, but I can't
- 7 quarantee that that didn't happen.
- 8 Q But you didn't see that happen that night?
- 9 A I didn't, no.
- 10 **Q** All you saw is people walking out to the car?
- 11 **A** Yes.
- 12 **Q** And then you saw the black male standing by his
- 13 car?
- 14 **A** When I came around the parking lot, yes, that is
- 15 what I saw.
- 16 **Q** And how long did it take before, for all of that
- 17 to happen for you to walk around?
- 18 **A** Oh, maybe thirty seconds, maybe a minute to walk,
- 19 you know, just to walk around the outside of the perimeter
- 20 of the lot.
- 21 Okay. And you said that the group of four were
- 22 shouting at the black male and the black female?
- 23 **A** At that point, yes.
- 24 Q Okay. And they were saying things, excuse me,
- like you are a pussy, you need security to walk you out?

1 A Yes.

:,''.

- 2 Q Okay. And that's when the black male was standing
- 3 by his, the driver's side door?
- 4 A Yes.
- 5 **Q** Now, you said that three --
- 6 **A** At least three.
- 7 Q At least three of them started advancing on the
- 8 black male, black female?
- 9 A They started to walk toward him and continue to
- 10 yell at him.
- 11 **Q** And the black male at that point was still
- 12 standing by his car door?
- 13 **A** Yes.
- 14 **Q** Okay. Now, just to clarify, for no reason, were
- 15 you specifically walking out with the black male or the
- 16 black female that night?
- 17 **A** No.
- 18 **Q** Okay. All right. Now, the fight starts and you
- 19 didn't see who started this fight, did you?
- 20 **A** No.
- 21 **Q** And you never saw any weapons?
- 22 A No. Not at the beginning, never saw anything
- 23 clear, no.
- 24 **Q** Okay. And you mentioned on direct that the group
- of males was trying to win the fight; is that right?

- 1 A Everybody was trying to win the fight I believe.
- 2 Q Okay. But the -- you said after the first person
- 3 was in the fight, the other three kind of jumped in.
- 4 A It wasn't at that point that I saw them jump in,
- 5 the point that I saw everybody get involved is after there
- 6 was already one of the gentlemen seriously injured.
- 7 Q Okay. So there was one point where there was one
- 8 guy was injured and then the rest of the group were fighting
- 9 the black male?
- 10 **A** Yes.
- 11 **Q** And everybody was throwing punches back and forth,
- 12 and fighting?
- 13 A Yes.
- 14 And then you mentioned that the, one of the group
- of males, I know it is confusing, because we don't -- you
- 16 are not sure of names. One of the group of four came up
- 17 behind the black male and actually hit him in his throat
- 18 with something?
- 19 A Yeah. His fist, maybe, maybe a ring, maybe a key,
- 20 something very simple, not like a weapon that I could see of
- 21 any kind.
- 22 Q But you don't know if it was a ring or a key or he
- 23 had --
- A Don't know what it was. From that kind of
- 25 movement it doesn't look like a normal punch, that is not

- 1 how you would hit somebody normally.
- 2 Q Okay. From what you saw it looked like he hit him
- 3 with something?
- 4 A Yes.
- 5 Q But you don't know what that object was?
- 6 **A** No.
- 7 **Q** Was it dark out there?
- 8 A Yes. Pretty dark.
- 9 Now, this fight taking place, you said the three
- 10 males, at least three of the males advanced towards the
- 11 black male. So where did the actual fight when you saw it,
- 12 where was that going on?
- 13 A When -- originally I saw them first fighting, it
- 14 was like in the black male and female were parked over here,
- 15 maybe a couple of spaces in. They were parked there and the
- other guys were parked here. The fight actually occurred
- 17 about maybe midway. I don't know exactly the distance, but
- 18 I was in -- when I walked around the vehicles, and I said I
- 19 walked around the outside, I came around this way and was
- 20 standing in front the vehicle, Leo, my other door guy was
- 21 standing behind the vehicle.
- 22 **Q** Okay.
- 23 A this point is where the guy was standing, the
- 24 gentleman, the black male was standing at the door of his
- vehicle and these guys were over here, and that's when they

- 1 yelled back and forth and started to advance. At that point
- when they started to advance, I told Leo to walk back
- 3 towards, to go call the police. I had walked from the front
- 4 of their vehicle to the back and when I turned around is
- 5 when I saw the fist fight.
- 6 Q Okay. Now, the first time you saw them fighting,
- 7 if you could show us, because I think it is a little clearer
- 8 on the bottom picture, if you can show us the very first
- 9 time you noticed anybody fist fighting according to this,
- 10 would it have been closer to the black male's car over in
- 11 this area?
- 12 A When I turned around, yes, because they were
- 13 pretty much directly behind me.
- 14 Q Okay. So it would have been closer to the black
- 15 male's vehicle where the fight actually started?
- 16 **A** Yes.
- 17 **Q** And then -- all right. Strike that. Sorry.
- 18 All right. You can have a seat, thank you.
- 19 MS. VICKERS: If I can just have a second, Your
- 20 Honor?
- 21 **THE COURT:** You may have.
- 22 BY MS. VICKERS:
- 23 **Q** Now, did you ever notice at one point when the
- 24 black male was surrounded by the group of four?
- 25 **A** Yes, I noticed when he was surrounded, yes.

- Okay. And did you see any of the men, the group
- of four, I am sorry, grab the black female or hit her or
- 3 grab her, throw her?
- 4 No, I didn't see that.
- 5 Q Okay. Did you -- you were working inside the club
- 6 primarily that night?
- 7 A Yes.
- 8 And did you pay any attention to the group of
- 9 four, did they seem intoxicated like they were drinking a
- 10 lot?
- 11 **A** Yes.
- 12 Q Okay. And do you know who had been at Thee
- 13 Dollhouse longer, either the group of four males or the
- 14 black male, black female?
- 15 A Cannot recall that, no.
- 16 \mathbf{Q} Okay.
- 17 MS. VICKERS: Nothing further, thank you.
- 18 REDIRECT EXAMINATION
- 19 BY MS. BARRA:
- 20 Q Sir, when you heard one of the group of four yell
- 21 something along the lines of you are a pussy, you need
- 22 security to walk you out, what was the defendant's response
- 23 to that?
- 24 A I don't need anybody to back me up.
- 25 **Q** And when he was saying that he didn't need anybody

- 1 to back him up, was he moving towards them?
- 2 A I can't recall at that point.
- Was he yelling back at them?
- 4 A Yes.
- 5 And was he out of his vehicle when he said that?
- 6 A Yes.
- 7 You stated that the group of four, they were
- 8 walking towards -- well, the three gentlemen were walking
- 9 towards the one gentleman who made contact with them,
- 10 correct?
- 11 **A** Yes.
- 12 **Q** What type of -- what type of pace were they
- 13 walking? Were they trying to get over there in a hurry?
- 14 **A** No.
- 15 **Q** They were just kind of casually walking over
- 16 there?
- 17 **A** Yes.
- 18 **Q** Then you also mentioned that they were kind of
- 19 huddled around the fight when the fight was taking place?
- 20 **A** Yes.
- 21 **Q** Did that appear to you that they were just
- 22 watching?
- 23 MS. VICKERS: I am gonna object. This is
- 24 speculation.
- 25 **THE COURT:** Sustained.

- 1 BY MS. BARRA:
- 2 Q How long were they standing around before somebody
- 3 got involved?
- A I can't recall. There was a lot going on.
- 5 When they arrived where the fight was taking place
- 6 --
- 7 **A** Uh-huh.
- 8 Q -- did anybody immediately jump in?
- 9 A No. Not that I saw.
- 10 **Q** And I believe you stated it was after that one guy
- 11 got stabbed that the others went in, correct?
- 12 **A** Yes. After one of the gentlemen was injured
- 13 severely, yes, I saw the other gentlemen join in.
- 14 **Q** Did you -- I know there's a lot going on, but did
- 15 you see the female get involved with the fight?
- A At one point she had ran up and jumped on the back
- of one of the individuals, but I don't recall exactly at
- 18 which point that was.
- 19 So she jumped on the back of one of the guys in
- 20 the group of four?
- 21 A Yes. While they were surrounding Mr. Dobbs, I
- 22 believe.
- 23 So he was just standing there when she jumped on
- 24 his back?
- 25 A The gentleman that she jumped on his back was,

- 1 yes, he was, at that time surrounding Mr. Dobbs.
- 3 A Not that I saw. No.
- 4 You also said that while they are in the club they
- 5 appeared to be drinking. Is that a normal thing for people
- 6 in that club to be doing?
- 7 A Yes.
- 9 else in the club that night?
- 10 **A** They were -- they were sitting in our champagne
- 11 lounge and a little bit unruly, like I had to keep making
- 12 reference to them to put their shirt on because one of the
- 13 gentlemen kept taking his shirt off and you can't do that in
- 14 there. I had to keep making -- so that was kind of a battle
- 15 with those gentlemen.
- 16 **Q** Did they seem violent in any way in the club?
- 17 A No. They didn't seem violent, no.
- 18 And were they -- when they were walking out, did
- 19 they appear to be able to walk fine?
- 20 **A** Yes. Yes.
- 21 And I believe just for clarification purposes, did
- 22 you say that it was always just one-on-one, even though
- 23 other people got involved?
- 24 Yes, I never recall everybody like jumping on top
- of him. Mr. Dobbs, I don't recall that, all I recall is him

- 1 being surrounded by individuals and each one of them were
- 2 taking a chance at him.
- 3 Q Is Thee Dollhouse, is that located in Orange
- 4 County, Florida?
- 5 **A** I assume so, yes.
- 6 Q Okay. Thank you, sir.
- 7 MS. BARRA: I have no further questions.
- 8 **THE COURT:** Any recross?
- 9 MS. VICKERS: Yes, Your Honor.
- 10 **RECROSS EXAMINATION**
- 11 BY MS. VICKERS:
- 12 **Q** Do you recall giving a statement to the police in
- 13 this case?
- 14 **A** Yes.
- 15 **Q** And that was like a tape recorded statement that
- 16 they took?
- 17 **A** Yes.
- 18 And do you remember telling them that as the fight
- 19 was progressing, that everybody jumped in on it and was
- 20 throwing punches?
- 21 **A** Yes.
- 22 Q Okay. So you do remember telling the police that?
- 23 **A** Yeah. What I was referring to is everybody was
- 24 surrounding him and taking a shot at him. Not everybody
- 25 actually jumping on top of him at one time.

- 2 example, somebody would -- sorry I am not a fighter. One
- 3 person would step in and the next person, next guy would
- 4 step in and the next guy, so there wasn't really a break at
- 5 any point where he didn't have somebody that was kind of
- 6 advancing on him taking a swing here or there?
- 7 A Okay. I am having trouble understanding the way
- 8 you put that.
- 9 You said that the men had surrounded the black
- 10 male?
- 11 **A** Yes.
- 12 **Q** And you had said that umm, that as the fight was
- 13 going on, the other gentlemen began to jump in and everybody
- 14 was throwing punches?
- 15 **A** Yes.
- Okay. So there wasn't a time during the middle of
- 17 the fight where everybody just stopped punching and
- 18 Mr. Dobbs walked off and said bye?
- 19 **A** I never saw that, no, no, no.
- 20 **Q** So they were pretty much around him at one point
- 21 or another, at least one of the four was, kind of throwing
- 22 punches or fighting?
- 23 A There was periods of time where like they were
- 24 judging like whether or not, like everybody was judging
- 25 whether or not to hit him because Mr. Dobbs was turning

- 1 toward each one of them individually, just to, you know,
- 2 look around to his surroundings, and then everybody was like
- 3 judging at which time somebody would jump in and take some
- 4 action, from what I saw.
- 5 Q Did you notice one of the group of four punching
- 6 Mr. Dobbs in the head?
- 7 A Yes. Well, yeah, he did take punches throughout
- 8 the fight. I don't recall who or actually which time those
- 9 were, but yeah, he did take some hits.
- 10 **Q** And did you ever happen to notice any of the black
- 11 male's injuries that he had on him while this was going on?
- 12 **A** No.
- 13 **Q** Did you notice anything?
- 14 A No, I really couldn't tell of any injuries.
- Okay. You are not saying there's not any, you
- 16 just weren't paying attention?
- 17 **A** I couldn't see. Yes.
- 18 And let me ask you a question, back when everybody
- 19 was leaving the club, did you have any occasion to notice
- 20 who left the club first either the group of four males or
- 21 the black male/female group?
- 22 A No, I did not.
- 23 Q Okay. And you said that once they are out in the
- 24 parking lot, you said at least three of the four men were
- 25 advancing towards the black male, black female, they were

| 1 | still yelling about how you are a pussy, you need security? |
|----|---|
| 2 | A Yes. |
| 3 | Q Things like that? |
| 4 | A Yes. |
| 5 | MS. VICKERS: Okay. Nothing further. |
| 6 | MS. BARRA: Nothing from the State. |
| 7 | THE COURT: May this witness be excused? |
| 8 | MS. BARRA: Yes. |
| 9 | THE COURT: Defense, may this witness be excused? |
| 10 | MS. VICKERS: He can be excused to go on about his |
| 11 | business, but not excused from the subpoena. |
| 12 | THE COURT: You remain on standby. You can leave |
| 13 | the courthouse. You need to know that someone may need |
| 14 | to get in touch with you, including the attorneys. |
| 15 | THE WITNESS: I am subpoenaed in Indiana tomorrow. |
| 16 | I am going to be gone the rest of the week. |
| 17 | (Conference at the Bench held on the record.) |
| 18 | THE COURT: He apparently has another subpoena. |
| 19 | MS. LASKOFF: He's the victim of a bank robbery in |
| 20 | Indiana. |
| 21 | THE COURT: The federal court subpoena would |
| 22 | certainly take jurisdiction over mine. |
| 23 | MS. LASKOFF: Sure. |
| 24 | MS. VICKERS: Could I get a requested recess to |

briefly consult with my client as to whether there is

| 1 | any more questions that need to be asked? He seems to |
|----|---|
| 2 | be adamant sitting over there about asking more |
| 3 | questions. I just need to review those with him if I |
| 4 | can't recall him at a later time. Just five minutes, |
| 5 | please. |
| 6 | (Whereupon, the following was in open court.) |
| 7 | THE COURT: Ladies and gentlemen, the attorneys |
| 8 | have requested a five minute recess so they can make |
| 9 | sure that they are finished with Mr. Idle since he will |
| 10 | not be available tomorrow. So I am going to ask that |
| 11 | you step into the jury room for five minutes. Do not |
| 12 | discuss the case amongst yourselves. Do not let anyone |
| 13 | discuss it with you. Leave your pad and pens on the |
| 14 | chair. They'll be there when you return. |
| 15 | (Jury exits the courtroom.) |
| 16 | THE COURT: And Mr. Idle, you can step down for a |
| 17 | few minutes. I ask that you not leave the floor until |
| 18 | the attorneys make sure they are finished with you. |
| 19 | Recess for five minutes. |
| 20 | (Whereupon a short recess was taken.) |
| 21 | THE COURT: All right. Ms. Vickers, did you have |
| 22 | an opportunity to determine if you are finished with |
| 23 | cross-examination of Mr. Idle? |
| 24 | MS. VICKERS: I did have an opportunity to |
| 25 | determine that. I just have two more questions for him, |

- 1 please.
- 2 **THE COURT:** Then let's bring Mr. Idle back in,
- 3 please.
- 4 (Whereupon: Mr. Idle entered the courtroom).
- 5 **THE COURT:** Mr. Idle, you are still under oath.
- 6 **THE WITNESS:** Okay.
- 7 **THE COURT:** Let's bring the jury back in.
- 8 (Jury enters the courtroom.)
- 9 **THE COURT:** You may be seated. Ms. Vickers, you
- 10 may proceed.
- 11 MS. VICKERS: Thank you, Your Honor.
- 12 BY MS. VICKERS:
- Now, Mr. Idle, when the yelling was going on back
- 14 and forth about needing security to walk him out to his car,
- 15 your impression was just guys being guys, guy talk?
- 16 **A** Yes.
- 17 Q Okay. And then I want to take you to the part of
- 18 the fight when we were talking about where the four came up
- 19 and surrounded the black male?
- 20 **A** Uh-huh.
- 21 **Q** At one point when that happened, umm, the black
- 22 male was kind of on the ground, or kind of squatted down?
- 23 A Squatted down, yes. Kind of like leaned over,
- 24 more in a defensive position. Not more --
- 25 **Q** Not like up in a fighting stance?

- 1 A Not like that. More lower than them, so to kind
- of get a better view of where they are, as he kept looking
- 3 around at each one of the individuals.
- 4 MS. VICKERS: Okay. Thank you.
- 5 **THE COURT:** Any additional questions, State?
- 6 **MS. BARRA:** Very briefly.
- 7 BY MS. BARRA:
- 8 Q Sir, when they said they were yelling you need to
- 9 walk out with security, were they saying that in a mocking
- 10 type tone, like making fun of the guy, or was it like a
- 11 serious threat?
- 12 **A** More of making fun of him.
- 13 MS. BARRA: Okay. I have no further questions.
- 14 **THE COURT:** Any additional questions, Ms. Vickers?
- 15 MS. VICKERS: No, Your Honor.
- 16 **THE COURT:** Thank you. May this witness be
- 17 excused?
- 18 **MS. VICKERS:** Yes.
- 19 **THE COURT:** You are free to go, sir. Thank you.
- 20 State, call your next witness.
- 21 MS. BARRA: Thank you, Your Honor. The State
- 22 calls Phillip Westfall.
- 23 Thereupon,
- 24 PHILLIP WESTFALL
- 25 was called as a witness and, having first been duly sworn,

- 1 testified as follows:
- 2 DIRECT EXAMINATION
- 3 BY MS. BARRA:
- 4 **Q** Good morning, sir.
- 5 A Good morning.
- 6 Q Could you please state your name and spell your
- 7 last name for the court reporter.
- 8 A Phillip Westfall. W-E-S-T-F-A-L-L.
- 9 Sir, on October 25th, 2006, were you working at
- 10 Thee Dollhouse?
- 11 **A** Yes.
- 12 **Q** What was your role at Thee Dollhouse?
- 13 **A** Valet attendant.
- 14 **Q** And on that date in question, did something catch
- 15 your attention that was unusual that night?
- 16 **A** At the end of the night?
- 17 **Q** Yeah, at the end of the night.
- 18 **A** Yes.
- 19 **Q** Okay. Was it after closing time?
- 20 **A** Yes.
- 21 **Q** And what are your duties after closing time, what
- 22 do you do?
- 23 A I park most of the employees' vehicles, and at the
- 24 end of the night I pull them up towards the front so they
- 25 don't have far to walk and that was a cold night and on cold

- 1 nights, I warm them up.
- 2 **Q** And on that night, did you hear somebody
- 3 screaming?
- 4 A Yes.
- 5 **Q** And who did you hear screaming?
- 6 **A** A female.
- 7 **Q** Where were you when you heard the screams?
- 8 A The front of the parking lot.
- 10 door of the Cabaret? I mean, of Thee Dollhouse?
- 11 A I was in the closest spot to the door of Thee
- 12 Dollhouse.
- 13 **Q** If I showed you a picture of the parking lot and
- 14 area, do you think that would assist in explaining to the
- 15 jury where everything was?
- 16 **A** Yes.
- 17 Okay. Let me just take a second to set this up.
- 18 You --
- 19 MS. BARRA: Your Honor, may I approach the
- 20 witness?
- 21 **THE COURT:** You may.
- 22 BY MS. BARRA:
- 23 **Q** Sir, it is a laser pen, so you can just point it
- 24 to the screen in helping you describe what happens. For the
- 25 record, I am going to be showing you photos under State's

- 1 Exhibit Number 2 and specifically the one I am showing now
- 2 is C4. Okay. Sir, is that a parking lot of Thee Dollhouse?
- 3 A Yes, ma'am.
- 4 • When you first heard a female screaming, what
- 5 direction was she screaming, like where was it coming from?
- 6 **A** This direction right here.
- 7 **Q** Was she by a car at the time?
- 8 A Yes.
- 9 And did it appear like it was her car, was she
- 10 over to it, about to get in?
- 11 **A** She was a passenger.
- 12 **Q** She was a passenger. Was she actually inside the
- 13 vehicle or was she outside the vehicle?
- 14 A She was standing outside the vehicle inside an
- 15 open door.
- 16 **Q** So the passenger door was open and she was
- 17 standing in there?
- 18 **A** Yes.
- 19 **Q** Do you recall what she was screaming, what she was
- 20 saying?
- 21 **MS. CHEN:** Objection, calls for hearsay.
- 22 **THE COURT:** Approach, please.
- 23 (Conference at the Bench held on the record.)
- 24 MS. BARRA: I am not using it for the truth of the
- 25 matter asserted. It is simply why it caught his

| 1 | attention, particularly on that night and why it drew |
|----|---|
| 2 | his attention to her. |
| 3 | THE COURT: What do you expect the answer to be? |
| 4 | MS. BARRA: I don't know. I don't know if he |
| 5 | what specifically he said. |
| 6 | THE COURT: If that is the only reason that you're |
| 7 | attempting to elicit it, I would think the raised |
| 8 | voices were sufficient without the actual words, so |
| 9 | sustain the objection. |
| 10 | (Whereupon, the following was in open court.) |
| 11 | THE COURT: Objection is sustained. |
| 12 | BY MS. BARRA: |
| 13 | Q Could you tell who she was screaming at or was it |
| 14 | just kind of a general scream? |
| 15 | A She was screaming at the one she was upset at. |
| 16 | ${f Q}$ Okay. Could you tell so, could you tell who |
| 17 | she was directing it towards? |
| 18 | A When I heard the screaming, I was there is a |
| 19 | line of parking spaces here. I was towards the front of the |
| 20 | building up here. She went as I heard her scream, I came |
| 21 | running back this way to this general area and she was |
| 22 | screaming in this direction. |
| 23 | Q And who was over in that direction? |
| 24 | A There were four gentlemen by their vehicle right |

here.

- 2 A I never heard anybody scream but her.
- 3 • And who was she with by that vehicle that she was
- 4 standing in the passenger door of?
- 5 A There was a black gentleman at the driver's side
- 6 of that vehicle.
- 7 And what did the black gentleman at the driver's
- 8 side of the vehicle do, if anything?
- 9 A Umm, when she was done screaming, there was one
- 10 gentleman walking in this direction. Their vehicle was
- 11 parked approximately right there. He came from the driver's
- 12 side.
- 13 Can you use this car as an example?
- 14 A He came from the driver's door around the back of
- the car to meet the other gentlemen and punched him in the
- 16 head.
- 17 **Q** Who punched him in the head?
- 18 A The gentleman that was with the female punched the
- 19 gentleman who was walking in that direction in the head.
- 20 **Q** Did he say anything before he punched him in the
- 21 head?
- 22 **A** No.
- 23 Q Did they meet before this happened or was this a
- 24 direct walk up and bam?
- 25 A This gentleman walked over. He came from the

- 1 driver's side around the back of the vehicle and socked him.
- 2 **Q** Socked him?
- 3 A Punched him in the head.
- 4 Q Where were the other three individuals when this
- 5 happened?
- A Around the silver vehicle, right here.
- 7 What happened after he got hit in the head, was he
- 8 able to fight the black gentleman?
- 9 A He half way spun around towards the ground, caught
- 10 himself with his hands.
- 11 **Q** At this time did you notice any blood on him?
- 12 **A** At that time, no.
- 13 After he spun around and caught himself, what was
- 14 the next thing that happened?
- 15 **A** The female screamed at him.
- 16 Screamed at the person who was on the ground?
- 17 **A** Who was hit. You got knocked out is what she
- 18 said.
- 19 **MS. CHIEN:** Objection, hearsay.
- 20 **THE COURT:** Overruled.
- 21 BY MS. BARRA:
- 22 Was she -- was she screaming this in a mocking
- 23 type of tone?
- 24 **A** She --
- 25 **MS. CHIEN:** Objection, speculation.

- 1 **THE COURT:** Overruled.
- 2 **THE WITNESS:** She screamed, you got knocked the
- 3 fuck out.
- 4 BY MS. BARRA:
- 5 Q And what was the black gentleman doing when this
- 6 happened?
- 7 A Just say the vehicle was here, he was basically
- 8 standing where he punched the other gentleman.
- 9 Now, did he -- did the black gentleman actually
- 10 have to walk towards the other gentleman? Was it something
- 11 that they met or did it appear that the, the Hispanic
- 12 gentleman, came over to him?
- 13 **A** The gentleman from this car traveled a farther
- 14 distance to come over to this vehicle.
- 15 **Q** Did the black gentleman have to travel any
- 16 distance or was it right at his car?
- 17 **A** I am going to use this black vehicle as an
- 18 example. Again, when he came from the driver's side, they
- 19 met about (indicating).
- 20 **Q** So approximately how far do you think the black
- 21 gentleman traveled to meet the guy?
- 22 **A** From the, this corner of the car, probably
- 23 10 feet.
- 24 **Q** Now, after the woman was screaming, you got
- 25 knocked out, what were the other three guys doing?

- 1 A second gentlemen from this vehicle, traveled
- 2 over to the black gentleman.
- 3 **Q** And what did he do when he got there?
- 4 A He swung at the guy twice, missed both times and
- 5 the black guy hit him.
- 6 Q Now, when this guy is swinging at the black
- 7 gentleman, was the other person from that group, the one who
- 8 just got knocked to the floor, was he up and swinging at the
- 9 black gentleman too or was it one-on-one?
- 10 **A** It was one-on-one. The other guy was still in
- 11 this area getting his wits together.
- 12 **Q** So he seemed dazed?
- 13 **A** Yes.
- 14 Q Okay. Now, when the second gentleman comes over,
- and you stated that the black gentleman hit him as well,
- 16 correct?
- 17 **A** Yes.
- 18 **Q** At that point could you see any blood?
- 19 A that point I did not notice any.
- 20 **Q** And what were the other, the remaining two guys
- 21 doing at this point?
- 22 **A** They were --
- 23 **Q** And when I say the two guys, I mean the ones by
- 24 that car?
- 25 A After this second gentleman got hit, a third one

- 1 from the silver vehicle was walking over and the female in
- this vehicle who was still by the passenger door area
- 3 attacked him.
- 4 **Q** What do you mean by attacked him?
- 5 A Kind of jumped on his back and was slapping,
- 6 swinging.
- 7 Q At the time she did this, was he hitting anyone or
- 8 trying to hit anyone?
- 9 A He was just on his way over.
- 10 **Q** And you said that he was walking over there. Was
- 11 he in a hurry to get there? Did it appear like he wanted to
- 12 get into the fight or was he just casually walking?
- 13 **A** I don't exactly recall.
- 14 Q Okay. So when she jumped on that gentleman's
- 15 back, what happened next?
- 16 A I was in fear for her, so I instantly went up to
- 17 break that altercation up.
- 18 **Q** Were you able to break that up?
- 19 **A** Yes.
- 20 **Q** And how did you break that up?
- 21 A I had a small canister of mace. I informed both
- 22 of them that I had mace, I would spray them. I was
- 23 screaming as loud as I could, an affirmative voice and
- 24 telling them to get back, break it up now, get back to their
- vehicles or I will mace you and you will be blinded.

- 1 **Q** And did they comply with that?
- 2 A Yes.
- 3 Q At any point did you see the guy strike the woman?
- 4 **A** No.
- 5 Q So, when they broke up, where did the woman go and
- 6 where did the guy go?
- 7 A She went back towards the vehicle and (pause) I
- 8 believe remained in that area but he did not comply with me
- 9 and go back to his vehicle.
- 10 **Q** So he stayed where the fighting was?
- 11 **A** In the general area, yes.
- 12 **Q** At what point did you or anybody there start
- 13 realizing that there was blood?
- 14 A Umm, there was a lot of stuff going on and I was
- in the middle of everything and defending myself as well as
- 16 trying to break up the fight. At one point the fourth
- 17 gentleman in the fight had the black guy by the shirt and
- 18 was punching him. That was the final thing that I broke up,
- 19 and somewhere right in there I looked around and saw blood
- 20 streaming from one quy's face onto his shirt, about chest
- 21 high, and running down. I saw blood on the other guy's
- 22 chest and not on his face and just kind of in a thought, I
- 23 am like to myself, I thought that's a lot of blood for --
- 24 MS. CHIEN: Objection, speculation.
- 25 **THE COURT:** Overruled.

- 1 **THE WITNESS:** I thought it is a lot of blood for
- this -- there weren't many punches thrown -- this much
- of a fight.
- 4 BY MS. BARRA:
- 5 Now you were talking about gentlemen and
- 6 gentleman. All the gentlemen that you saw with blood on
- 7 them, were they in the group of four?
- 8 A Yes.
- 9 Q Did the black gentleman appear to have a lot of
- 10 blood on him?
- 11 A No, ma'am. The only injuries I saw him sustain
- were the fourth guy that he had him by the back of the shirt
- and was punching him in the side of the head, but I did not
- 14 see any blood result from that.
- 15 And you stated that you were able to break it up
- 16 at that point, correct?
- 17 **A** Yes.
- 18 **Q** So, when you told them to break it up, did the
- 19 fourth guy release the black gentleman?
- 20 **A** Yes, he did. I entered his face, once again,
- 21 presented the mace to his face and told him to break it up
- 22 and go to his vehicle.
- 23 **Q** Okay. So now that the fight is broken up, what
- 24 happened, where did everybody go?
- 25 **A** I was in this general area and I am going to use

- 1 this car as an example again, the passenger door was open.
- 2 I was about here. Everybody was spread out. The black
- 3 gentleman was by the back of the car. There was another guy
- 4 over here and a gentleman walking in this direction from the
- 5 back of the car. The next thing that happens is when he got
- 6 here, I turned and looked and he stopped, his right leg
- 7 wobbled and he fell backwards just like a tree and, with no
- 8 trying to catch his self or anything.
- 9 **Q** Did you go to him?
- 10 A I -- yes, I ran to him, put my hand on his head to
- 11 feel his head. As I looked at him, his eyes rolled back
- into his head and went left. There wasn't any blood on his
- 13 face. I looked at his chest and he had two stab wounds in
- 14 his chest.
- 15 **Q** Now, which one -- the person that you were holding
- 16 his head, do you recall what time he entered the fight in?
- 17 **A** I believe he was the first one over.
- Now, when you are holding the back of his head,
- 19 was everybody, all parties involved in the fight still on
- 20 the scene at that time?
- 21 **A** Yes.
- 22 **Q** Did anybody leave the scene?
- 23 **A** Yes.
- 24 **Q** Who left the scene?
- 25 A The black gentleman and the female in the car that

- 1 was over there.
- 3 A Yes.
- 4 Q And how was it made known, did somebody yell that?
- 5 A By the very end of the fight, I believe that
- 6 people had come out the back door and I told them that the
- 7 police were on their way. I was saying anything I could to
- 8 stop them, everything.
- 9 Did you try to stop the black gentleman from
- 10 leaving the scene?
- 11 **A** Well, I was holding the gentleman's head and
- 12 realized that he had been stabbed. I said out loud, there
- was a party of people out there. I said out loud, this guy,
- 14 I said that mother fucker stabbed this guy, stop him.
- Do you know where he was, for example, was he in
- 16 the car when you were saying this or was he still on the way
- 17 to the car when you said this?
- 18 A Everybody was still outside of the vehicles.
- 19 **Q** So the black gentleman was still outside the
- 20 vehicle when you said this?
- 21 **A** Yes.
- 22 **Q** And did he stop?
- 23 A No. He ran to the -- jumped in the car, shut the
- 24 door. As I said, he was stabbed. One of the gentleman from
- 25 this vehicle came over to him. I ran from this spot to the

- 1 back, to the driver's door. I was going to mace him so he
- 2 couldn't drive out of the parking lot.
- 3 So you ran to the driver's door of the black
- 4 gentleman's car?
- 5 A Yes.
- 6 **Q** And what happened when you got there?
- 7 **A** The window was up.
- 9 it starting to travel out?
- 10 **A** It was started and I -- as soon as I realized the
- 11 window was up, I went to the back of the car. I carry a pen
- 12 here like this, and I carry valet tickets in my back pocket.
- 13 And I grabbed one of them to write the tag number down.
- 14 There was no tag on the vehicle. So I looked to get the
- make and model, and it was an Acura TL and instantly grabbed
- 16 my cell phone and dialed 911.
- Okay. Sir, I'm showing you what has been marked
- 18 Composite B, I am sorry, State's Exhibit 3, and I am showing
- 19 you B3. Is that the vehicle that you saw that night?
- 20 A Yes, ma'am.
- 21 **Q** And when were you trying to take the tag down, in
- this spot right here, is that a temporary tag?
- No, ma'am, I don't believe. I don't believe so.
- 24 **Q** But you couldn't see that?
- 25 **A** It's not a Florida temporary tag.

- 1 Q Okay. Now, after you had tried to stop the
- 2 vehicle you got the make and model of the vehicle. Did you
- 3 do anything else or did you see somebody else get involved?
- A At the time I was holding the gentleman's head,
- 5 the valet attendant from across the street had heard me
- 6 screaming and drove his truck over there to -- he told me
- 7 that he thought I was in trouble, so he drove his truck over
- 8 to help me.
- 9 **Q** Now, he was across the street?
- 10 **A** Yes, at the Cabaret.
- Did he come over to where you were, and did you
- 12 have a conversation with him?
- 13 A No, he was in his vehicle and when I screamed,
- 14 stop that guy, he just stabbed this man, he -- and when the
- 15 vehicle pulled off --
- 16 **Q** Do you want to see that photo again?
- 17 **A** I was here. My employee pulled up to about here
- 18 and came to a screeching stop. When I said go get him,
- 19 this, this vehicle pulled, there is a little island right
- 20 there. It is just about two or three feet wide. The
- 21 vehicle pulled around that and tried to exit out of the
- 22 southeast entrance to the parking lot.
- 23 **Q** So the black male was trying to exit that way?
- 24 A Yes. My employee went this way and went down and
- 25 tagged the rear end of the car to, I believe try and spin

- 1 him out. He tried to stop him. He hit that vehicle with
- 2 his vehicle.
- Okay. And did that -- and he was still in the
- 4 parking lot when this occurred, right?
- 5 A Yes.
- 7 A He was traveling at a speed to escape, and he was
- 8 traveling at a speed to try and stop him, keep up and stop
- 9 him.
- 10 **Q** Did that stop him?
- 11 A No, ma'am.
- 12 What happened -- where did the black gentleman's
- 13 vehicle go?
- 14 MS. CHIEN: Objection is speculation.
- 15 **THE COURT:** Overruled, if he knows.
- 16 **THE WITNESS:** You asked where did the black
- 17 gentleman's vehicle go?
- 18 **Q** Yeah, that you saw.
- 19 A There are three entrances to the front of Thee
- 20 Dollhouse, a south, middle and north. He went out the south
- 21 entrance and made a right going south on OBT.
- 22 And did your friend across the way follow him?
- 23 **A** Yes, ma'am.
- 24 **Q** What happened next, did the police arrive?
- 25 **A** Yes, about three or four people were on the phone

- 1 with 911 along with myself.
- 3 at Thee Dollhouse?
- 4 A Before I got off the phone with 911.
- 5 **Q** They had pulled in?
- 6 A Yes.
- 8 was when it turned right and went away, or did you see it
- 9 again at any point?
- 10 A That was the last time I saw it.
- 11 MS. BARRA: Thank you. I have nothing further at
- 12 this time.
- 13 **THE COURT:** Cross-examination.
- 14 CROSS-EXAMINATION
- 15 BY MS. CHIEN:
- 16 **Q** Morning, Mr. Westfall. I just want to be clear,
- 17 can you tell the jury where you were at when you -- right
- 18 before the fight broke out?
- 19 A Once again, there are two aisles of parking spaces
- 20 right here. The corner of the building is somewhere right
- 21 over here. There are six parking spaces along the edge of
- 22 the -- along the edge of the building, the south side of the
- 23 building. There's five spaces and a handicap spot there. I
- 24 was in the -- if you went handicap, 9, 8, 7, 6, 5, I was in
- 25 5.

- Okay. So, when you heard the yelling, the way
- 2 that you saw the cars positioned was the four gentlemen,
- 3 their car was that Chrysler to the right?
- 4 A This vehicle.
- 5 Q And the car that Mr. Dobbs was in was about
- 6 40 feet away, is that correct?
- 7 A I'd say there's two spaces between these vehicles.
- 8 It would be -- it would be one, two, three, four, five or
- 9 six spaces away, and one row back.
- 10 **Q** So, the distance between the four gentlemen and
- 11 Mr. Dobbs was approximately, would you say, 40 feet?
- 12 **A** Five parking spaces.
- 13 **Q** Okay.
- 14 **A** To the width of them, I am not exactly positive.
- 15 **Q** Okay.
- 16 **A** Five --
- 17 **Q** Now, at some point it would be fair to say that
- 18 you never saw Mr. Dobbs move his car, is that correct?
- 19 A No, no, ma'am, not until the end.
- 20 **o** So what I said was an accurate statement?
- 21 **A** I never saw him move his vehicle.
- 22 **Q** Right. And the fight broke out by the rear of
- 23 Mr. Dobbs' car, is that correct?
- 24 **A** The parking spot to the right of his vehicle.
- 25 And you saw the Hispanic male walk thirty feet

- 1 towards Mr. Dobbs, is that correct?
- 2 A Yes, ma'am.
- 3 Q And Mr. Dobbs only walked about maybe 10 feet?
- 4 **A** Yes, ma'am.
- 5 Q And at some point during the fight, your back was
- 6 to the fight, is that correct?
- 7 A Several, probably, because I was in the middle and
- 8 the fight was -- there was people all around me.
- 9 Okay. So you weren't paying attention to
- 10 everything, I mean, sometimes your back was to the fight?
- 11 **A** Yes.
- 12 Okay. And at some point you also saw a Hispanic
- 13 male holding down Mr. Dobbs, is that correct?
- 14 A I saw him holding him by the back of his shirt.
- Okay. And this gentlemen was punching Mr. Dobbs
- 16 in the head?
- 17 **A** In the side of the head.
- 18 **Q** Let's talk about the beginning of the fight. The
- 19 first guy that walked over to Mr. Dobbs, after that punch,
- 20 you saw no blood on the first guy, is that correct?
- 21 **A** I did not notice, no, ma'am.
- 22 Q Okay. And then the second guy who also, umm,
- 23 fought Mr. Dobbs, you also did not see any blood on him as
- 24 well, is that correct?
- 25 **A** In the beginning, no.

- 1 Q And the female that was also there, you also saw
- 2 somebody run up and kick the female in the back, is that
- 3 correct?
- 4 A I never saw her get hit. I saw her attack the guy
- 5 and instantly went to break that up.
- 6 **Q** Well, you gave a statement to the police that
- 7 night; is that correct?
- 8 A Yes.
- 9 Okay. Do you recall telling the police officer
- 10 that somebody ran up and kicked the female in the back, she
- 11 got up and then the gentleman from the car eye witnessed
- 12 him, but do you recall telling the police officers that
- 13 somebody ran up and kicked the female in the back?
- 14 A No, ma'am.
- When you saw Mr. Dobbs leaving, was it Mr. Holiday
- 16 that followed him?
- 17 **A** Yes, ma'am.
- 18 **Q** And he was in a truck?
- 19 **A** Yes, ma'am.
- 20 And would you say that they were both going pretty
- 21 fast?
- 22 **A** Yes, ma'am.
- 23 **Q** And you saw Mr. Holiday hit Mr. Dobbs' car, is
- 24 that correct?
- 25 **A** Yes, ma'am.

- MS. CHIEN: May I have a moment Your Honor? 1 2 THE COURT: You may. BY MS. CHIEN: 3 Mr. Westfall, would it refresh your recollection 4 0 if I were to show you a transcript of the police officers 5 that night? 6 MS. BARRA: Objection, Your Honor. May we 7 8 approach? THE COURT: You may. 9 (Conference at the Bench held on the record.) 10 MS. BARRA: He hasn't indicated that he doesn't 11 have a fresh recollection of what occurred that day. 12 The defense attorney just stated would it refresh your 13 recollection, but there has been nothing on the record 14 that indicates his recollection isn't refreshed. 15 THE COURT: All right. I am going to overrule the 16 objection. 17 (Whereupon, the following was in open court.) 18 **THE COURT:** Objection is overruled. 19 20 BY MS. CHIEN: So, Mr. Westfall, would it help you to refresh 21 Q your recollection if I were to show you the transcript that 22 you gave to the police officers on the night of the 23
- 25 **A** It is possible.

incident?

- 1 **Q** Okay.
- 2 MS. CHIEN: May I approach the witness, Your
- 3 Honor?
- 4 **THE COURT:** You may.
- 5 BY MS. CHIEN:
- 6 Q Can you please read this silent to yourself and
- 7 let me know when you are done reading.
- 8 A All right. It did say that.
- 9 Can I take that back now? Are you done?
- 10 A Yes.
- 11 **Q** Mr. Westfall, has your recollection been
- 12 refreshed?
- 13 **A** Yes.
- 14 Q Okay. And isn't it true that you gave a statement
- to the police that at some point somebody ran up and kicked
- 16 the female in the back?
- 17 **A** I did say that.
- 18 Okay. And isn't it also true that all of a sudden
- 19 four guys were fighting the couple?
- 20 **A** That's a general statement.
- 21 **Q** Okay. But isn't it true that at some point that
- 22 four guys were fighting the couple?
- 23 **A** (pause).
- 24 Would it refresh your recollection if I were to
- 25 show you that transcript again?

- 1 A You can read that out loud. I know what I said.
- 2 Four gentlemen fought two people.
- 3 **Q** All right.
- 4 A It is very general.
- 5 \mathbf{Q} Okay.
- 6 MS. CHIEN: I have no other questions.
- 7 **THE COURT:** Any redirect?
- 8 MS. BARRA: Yes, Your Honor.
- 9 **REDIRECT EXAMINATION**
- 10 BY MS. BARRA:
- 11 **Q** Sir, did four gentlemen fight two people all at
- 12 the same time?
- 13 **A** Meaning?
- 14 **Q** Meaning at one moment all four of them were
- 15 beating on two people?
- 16 A No, ma'am.
- 17 **Q** Is that what you meant by your statement?
- 18 A No, ma'am.
- 19 What did you mean when you said that?
- 20 **A** I was in the middle of a six person fight. It was
- 21 not all going on at once. There were separate fights going
- 22 on at once. The girl and guy, there was guy on guy.
- 23 **Q** Did you ever see more than one person hitting
- 24 Mr. Dobbs at one time?
- 25 A No, ma'am.

| 1 | Q And in regards to the women, is it your testimony |

| 2 | that she attacked him; is that right? |
| 3 | A The third gentlemen walking over? |
| 4 | Q The third gentlemen. |

| 13 | THE COURT: Okay. |
| 14 | MS. VICKERS: And just to let you know, second |
| 15 | issue I think we should briefly address is kind of a, |
| 16 | somewhat of a Nelson hearing with Mr. Dobbs. He's |
| 17 | expressing |
| 18 | THE DEFENDANT: Frustration. |
| 19 | MS. VICKERS: dissatisfaction with our |

that I want asked, and I feel that they are crucial to

just allow me the benefit of hearing that out.

THE COURT: All right. Do you want to tell me what those specific questions are or not? I am not requiring you to do that.

of instances where witnesses have been up on the stand, or so-called victims and questions that I wanted to, you know, as you see how she brought out the fact that he denied that someone had kicked my girl in the back and then she brought it out that it was in his statement to the police, and then he remembered. | 1 | THE COURT: And you are talking about witnesses |

| 9 | and no blood was found on anything, but other than |
| 10 | that, I don't think it is relevant. |
| 11 | MS. LASKOFF: I do. |
| 12 | THE COURT: Subject to tying it up at a later time |
| 13 | I will admit it. |
| 14 | (Whereupon, the following was in open court.) |
| 15 | BY MS. LASKOFF: |
| 16 | Q You went from the hospital to the vehicle and then |
| 17 | you went back to the scene where the, at Thee Dollhouse, |
| 18 | correct? |
| 19 | A Yes. |
| 20 | Q And after processing the scene at Thee Dollhouse, |
| 21 | where did you go at this point? |
| 22 | A (pause). |
| 23 | Q Did you go to the medical examiner's office? |
| 24 | A Yes, I did. |
| 25 | Q And do you recall when you were at the medical |

- 1 examiner's office what it is that you did?
- 2 A I collected major case prints from the victim.
- 3 **Q** You did what?
- 4 A I collected major case fingerprints from the
- 5 victim and some clothing.
- 6 Q Okay. Did you collect a DNA card from the victim?
- 7 A Yes.
- 8 Q And can you just explain to the jury what that
- 9 means?
- 10 A Whenever somebody dies, we need their DNA standard
- 11 since that's the last opportunity we will have it, so they
- 12 usually will take a tube of blood. They'll collect it or
- 13 they'll make a card that has the standard on it.
- 14 And when you say a standard, for people that don't
- 15 know about DNA and all this forensic kind of stuff, what
- 16 does that mean?
- 17 **A** It just means -- everybody has their own unique
- 18 DNA, and what they'll do is, umm, they'll take either a swab
- 19 from their mouth or they'll take some blood and they'll just
- 20 smear it on a card and that person's DNA profile is actually
- in that blood that's attached to the card and we can extract
- it later to be compared to any evidence.
- 23 **Q** Okay. And then this individual that we are
- 24 referencing that you responded to the medical examiner's
- 25 office for, which victim specifically was that, do you

- 1 remember what his name was?
- 2 A His name was Will, or William Troy.
- 3 Q Okay.
- 4 MS. LASKOFF: If I may approach the witness, Your
- 5 Honor?
- 6 **THE COURT:** You may.
- 7 BY MS. LASKOFF:
- 8 Showing you what has been marked as Exhibit J. Do
- 9 you recognize this?
- 10 **A** Yes.
- 11 **Q** How do you recognize that?
- 12 **A** It has my label on it, noting it is a DNA card
- 13 with my initials and date on there.
- 14 Q Okay. And can you, again, cut it open, let me
- know if it's in substantially the same condition as when you
- 16 obtained it and submitted it into evidence?
- 17 **A** Yes, it is.
- 18 **Q** Okay. At this time we would move to have Exhibit
- 19 J into evidence as State's 10?
- 20 **THE CLERK:** Yes.
- 21 **THE COURT:** Any objection?
- 22 **MS. VICKERS:** I am going to object to relevance
- for the same reasons as the previous objection.
- 24 **THE COURT:** The objection will be overruled.
- It'll be admitted conditionally being tied up later.

MS. LASKOFF: Yes, Your Honor. 1 BY MS. LASKOFF: 2 Now, did you have any other direct involvement 3 with any processing yourself in this case? 4 Yes, I did. 5 A And what was that? 6 0 I processed both the victim's car and the other 7 A car that was at Town Center Boulevard. 8 Okay. And when you talk about processing, can you 9 Q tell the jury what does that mean? 10 Processing a vehicle involves the same thing as if A 11 it was a crime scene, photographs, checking any evidence 12 that is on there, umm packaging it. 13 14 0 Okay. MS. LASKOFF: If I can just have a moment, Your 15 16 Honor? 17 THE COURT: You may. MS. LASKOFF: I have nothing further from this 18 witness, Your Honor. 19 THE COURT: Cross-examination? 20 MS. VICKERS: Your Honor, can we approach, 21 briefly? 22 **THE COURT:** You may. 23 (Conference at the Bench held on the record.)

MS. VICKERS: Your Honor, I am going to be

| 24 | A Good afternoon. |
| 25 | Q Now, in your report you had stated that there was |

- a blood trail in the parking lot that lasted over about
- 2 eight parking spaces; is that correct?
- 3 A Yes.
- 4 Q And do you know how wide a parking space is, a
- 5 standard parking space?
- 6 A Probably 10 feet.
- 7 **Q** So we are talking about a span of maybe 80 feet?
- 8 A It was more like a square area. It wasn't 80 feet
- 9 long, no.
- 10 **Q** Okay. Now, you also had notated in your report
- 11 when you go out to the scene and you are taking photographs
- 12 and you set up, you set up cones, don't you?
- 13 **A** Yes, ma'am.
- 14 **Q** And the cones are so you can identify where a
- 15 certain piece of evidence might be?
- 16 **A** Yes.
- 17 **Q** And in this case you laid out several cones or
- 18 identification marks in the parking lot of Thee Dollhouse,
- 19 is that correct?
- 20 **A** Yes.
- 21 And do you recall you placed a cone that you have
- 22 labeled in your report as number 22?
- 23 **A** Yes, I do.
- 24 Okay. And could you tell the jury what cone
- 25 number 22 signifies in your report?

- 1 A It was a small amount of blood drops.
- 2 Q Okay. And is it your understanding that those
- 3 blood drops are where the Acura was?
- 4 A I never knew where the Acura was.
- 5 Q Okay. And then there was another cone, number 10,
- 6 that you have marked in your report, is that correct?
- 7 A Yes, ma'am.
- 8 And cone number 10, what does that signify?
- 9 **A** It was a trail of blood drops.
- 10 **Q** Okay. And number 10 is close to what?
- 11 **A** The victim's car.
- 12 **Q** Okay. And you are saying victim's, is that
- information you get from the detectives?
- 14 **A** Yes.
- 15 **Q** Because you weren't there?
- 16 **A** Right.
- 17 **Q** Obviously?
- 18 **A** Right.
- 19 And so you don't know who's a victim or who's not
- 20 in this case?
- 21 **A** True.
- 22 So, do you recall the distance from point 22,
- 23 which is I am assuming the farthest south point of blood
- 24 that you have, is that correct?
- 25 **A** Yes, it is.

- Okay. So, cone 22 signifies the blood that is
- 2 farthest south, correct?
- 3 A Yes.
- 4 Q And then cone 10 signifies the blood that you have
- 5 farthest north, is that correct?
- 6 A Correct.
- 7 And do you know how long the distance is between
- 8 10 and 22?
- 9 A I did not measure those, another investigator did.
- 10 **Q** Okay. Who is that?
- 11 **A** Allison Wright.
- 12 Q Okay. Thank you. Now, you took pictures of the
- 13 Acura, is that right?
- 14 A Yes, ma'am.
- And I'm going to show you what has been previously
- 16 marked as Defense I for identification.
- 17 **MS. VICKERS:** May I approach?
- 18 **THE COURT:** You may.
- 19 MS. VICKERS: Thank you.
- 20 BY MS. VICKERS:
- 21 **Q** If you can just look at this and hold it down low
- 22 and let me know when you're done. Umm, do you recognize
- 23 those?
- 24 **A** Yes, I do.
- 25 **Q** And what is it?

- 1 A Those are pictures of the Acura.
- 2 Q Okay. And are those pictures that you took?
- 3 A Yes, ma'am.
- 4 Q And that's how you recognize them?
- 5 **A** Yes.
- 6 Q And is -- are the pictures a fair and accurate
- 7 depiction of how the Acura looked on October 25th of 2006?
- 8 A Yes, they are.
- 9 Okay. Now, you noted in your report that there
- 10 are 22 different places where blood is found on the outside
- 11 of the Acura, is that right?
- 12 **A** Yes.
- 2 So that means 22 different spots or splatters of
- 14 blood, correct?
- 15 **A** Correct.
- 16 And that would lead you to the conclusion that
- 17 blood, some of it is in splatters, is that correct, not
- 18 droplets?
- 19 **A** Correct.
- 20 And so blood splatters because it flies, correct?
- 21 **A** Correct.
- 22 Okay. And so that would lead you to the
- 23 conclusion that the fight took place close to the Acura, is
- 24 that correct?
- 25 **A** Yes, it would.

- 1 **Q** Because there wasn't any blood found on the
- 2 exterior of the Chrysler, was there?
- 3 A There was blood, yes.
- 4 **Q** On the outside of it?
- 5 A Yes.
- 6 Q Okay. And how many points of blood were on the
- 7 outside of the Chrysler, what you are referring to as the
- 8 victim's car?
- 9 A About two or three.
- 10 **Q** Two or three spots?
- 11 **A** Uh-huh.
- 12 **Q** I am sorry?
- 13 **A** Yes. I am sorry.
- 14 **Q** And the Acura also has a dent on the back
- 15 passenger side, is that correct?
- 16 **A** Yes, it did.
- 17 **Q** Okay. And you photographed that?
- 18 A Yes, I did.
- 19 **Q** All right. Now, when you first went to the scene
- 20 of where the Acura was, you went to the actual place, like
- on the side of the street where it was pulled over?
- 22 **A** Yes.
- 23 And do you recall whether the windows were rolled
- 24 up or down?
- 25 **A** I don't recall, can I look at my report and see if

1 I made a note?

- 2 **Q** Sure, please do.
- 3 A All the windows were up.
- 4 Q Okay. And would that have been in the same
- 5 condition that it was when the police pulled it over?
- 6 A I don't know what condition it was when they
- 7 pulled him over.
- 8 Q As a member of the Orange County Sheriff's Office
- 9 when there's a crime scene, everybody is pretty much taught
- 10 to leave it as is, don't alter or change anything?
- 11 **A** They should.
- 12 Q Okay. Did you ever run any checks to see who the
- 13 gun belonged to?
- 14 A I couldn't.
- 15 **Q** Okay. Why not?
- 16 **A** Its serial number was obliterated.
- Okay. And if that happens, there is no way to
- 18 trace who the gun belongs to?
- 19 A Not until FDLE works it and can bring up the
- 20 serial number again.
- 21 **Q** Do you know if that was done in this case?
- 22 A It was requested. I don't know if it was done.
- 23 And I know that you take fingerprints and DNA, do
- 24 you do any testing to see what the results are of those
- 25 collections?

- 1 A No, I don't.
- 2 Q Okay. And did you collect any kind of what's
- 3 called a gunshot residue kit?
- 4 A No, I did not.
- 5 Q Okay. Do you know who did in this case?
- 6 A Allison Wright.
- 7 Q Okay. Would have collected that?
- 8 A Yes.
- 9 Could you just tell us what a gunshot residue kit
- 10 is?
- 11 A A gunshot residue kit is basically a little sticky
- 12 pad that you can take and touch somebody's hands with it and
- if there is any lead, antimonium or barium which is some of
- 14 the chemicals that comes out of a gun on your hand, then it
- will stick to that little sticky pad and then a scientist
- 16 will look at it under a standing electronic microscope and
- 17 he can see those little particles.
- 18 **Q** Okay. And you-all use this primarily, this kit
- 19 for what purpose?
- 20 **A** We use it to try to determine if somebody fired a
- 21 weapon.
- 22 Q Okay. And do you run any tests on the firearm to
- 23 see if it has been eventually fired or not?
- A No, I do not.
- 25 **Q** Who does that?

- 1 A FDLE.
- 2 Now, quickly, back to the Acura, we talked about
- 3 the 22 different points of where blood is found on the
- 4 outside of it. Is the majority -- are the majority of those
- 5 spots found on certain regions or areas of the car?
- 6 A Yes, there were.
- 7 And could you explain to the jury what area of the
- 8 Acura that the majority of the blood is found on?
- 9 A On the back of the Acura along the trunk area and
- 10 along the passenger's fender area is where the majority of
- 11 the areas of blood were. The scale only represents an area.
- 12 Even though there's 22 scales, the area for each scale was

- 14 **Q** I am showing you what has been marked as State's
- 15 Exhibit 3 that has been moved into evidence. Could you take
- 16 a look at this. Now, looking at the picture of the Acura
- 17 you said the majority of the blood was found where?
- 18 **A** On the back area, the trunk area.
- 19 **Q** This part?
- 20 **A** Yes, and along the passenger side rear area, over
- 21 the tire.
- 22 **Q** So then in this little quadrant over here?
- 23 **A** Right. And it went over the back windshield onto
- 24 the top of the car.
- 25 **Q** So you said there was blood on the back

- 2 do you wait awhile? How does that work?
- 3 A No, I draw it when I am on the scene, and when I
- 4 go back to the office, I will put it into the computer so it
- 5 makes sense to everyone.
- 6 MS. LASKOFF: If I may approach the witness, Your
- 7 Honor?
- 8 **THE COURT:** You may.
- 9 BY MS. LASKOFF:
- 10 **Q** I am showing you what's marked for identification
- 11 purposes as L. If you could look at this. Do you recognize
- 12 what that is?
- 13 **A** Yes, I do.
- 14 **Q** And what is that?
- 15 **A** It is the sketch that I made at the scene.
- 16 **Q** Okay. Representing?
- 17 **A** Where all my cones were that I placed on the
- 18 scene.
- 19 **Q** Okay. And the cones are representing what?
- 20 **A** Umm, the numbers represented blood or suspected
- 21 blood and the letters represented pieces of evidence.
- 22 Q Okay. Has that changed in any way?
- 23 **A** No.
- 24 **Q** Okay.
- 25 MS. LASKOFF: At this time we move to have Exhibit

- 23 parked?
- 24 **A** No.
- 25 **Q** Okay.

- 1 MS. LASKOFF: I have nothing further, Your Honor.
 2 THE COURT: Recross-examination?
 3 MS. VICKERS: Yes.
- 4 RECROSS-EXAMINATION
- 5 BY MS. VICKERS:
- 6 Q I am not gonna try to make you step down, but I'd
- 7 like to try to show the jury, so, are you okay?
- 8 A I am fine.
- 9 **Q** I am just gonna be showing you what has been moved

- 24 And is this picture the color photo of the cars
- 25 with the crime scene tape around it, is that kind of a

- 3 A Yes, it is.
- 4 **Q** Now, vehicle number 3 on your diagram represents
- 5 this car right here, is that correct?

- 6 Q Okay. Did you become involved in a stabbing
- 7 investigation that occurred on the night of October 25th,
- 8 2006 at Thee Dollhouse?
- 9 A Yes, I did.
- 10 Okay. And can you explain to the jury how it is
- 11 you first became involved in this case?
- 12 **A** Umm, I was called to our central operations
- building at the sheriff's office to photograph and collect
- 14 buccal swabs from suspects.
- Okay. And did you, in fact, do this?
- 16 **A** Yes, I did.
- 17 **Q** Okay. And when you -- when you say you responded
- 18 to your criminal investigations division, sorry, to collect
- 19 buccal swabs, what's a buccal swab?
- 20 A Buccal swabs is the swabbing of the inside of the
- 21 cheek. It is used for a DNA standard.
- 22 **Q** And what do you mean DNA standard, for everyone
- 23 that --
- A Comparison against blood evidence, saliva,
- 25 anything that you need to compare DNA for.

- Okay. And from whom did your collect a buccal
- 2 swab?
- 3 A I collected buccal swabs from a John Dobbs and a
- 4 Deanna Washington.
- 5 **Q** Okay.
- 6 MS. LASKOFF: If I could approach the witness,
- 7 Your Honor?
- 8 **THE COURT:** You may.
- 9 BY MS. LASKOFF:
- 10 **Q** I am showing you what is marked for identification
- 11 purposes as K. Do you recognize what this is?
- 12 **A** Yes.
- 13 **Q** And how is it that you recognize what that is?
- 14 A It has my evidence label and my seal.
- 15 **Q** Okay. And what is that?
- 16 **A** These are buccal swabs from John Dobbs.
- 17 Okay. Can you open the package. There's a pair
- 18 of scissors there, and let me know whether or not is the
- 19 evidence that you put in there in substantially the same
- 20 condition as when you placed it in inside the envelope?
- 21 **A** It appears to be.
- 22 MS. LASKOFF: At this time we'd move to have
- Exhibit K moved into evidence as State's 12.
- 24 **THE COURT:** Any objection?

| 18 | BY MS. LASKOFF: | |
| 19 | Q Sir, can you state your name for the record? | |
| 20 | A Deputy Herbert Mercado. | |
| 21 | Q And where is it that you work, Deputy? | |
| 22 | A I work in Sector 4. | |
| 23 | Q At what agency? | |
| 24 | A Orange County Sheriff's Office. | |
| 25 | Q And what is your job there? | |

- 1 A I am a deputy sheriff, patrol deputy.
- 2 **Q** I am sorry?
- 3 A I am a patrol deputy for Sector 4.
- 4 **Q** What is that to mean?
- 5 A Basically ride around in our police cars and fight
- 6 crime.
- 7 **Q** Do you respond to calls?
- 8 A Yes, I do.
- 10 A Approximately a year and I believe nine months
- 11 now.
- 12 **Q** Now, let me ask you back on October 25th, 2006,
- 13 early morning hours, were you on duty?
- 14 **A** Yes, I was.
- And what was your duty at that point, was it the
- 16 same thing, Sector 4?
- 17 **A** Yes, it was.
- 18 And did you respond to a call?
- 19 **A** Umm, I assisted Deputy Tom Hutchins in a traffic
- 20 stop.
- 21 **Q** Okay. Let me ask you about that. What is it that
- 22 you-all learned in order to have this traffic stop happen?
- 23 **A** Basically we responded to a call of a possible
- 24 aggravated battery that happened in a nightclub and the
- 25 suspect vehicle was heading southbound on Thompson towards

- 1 our location. We got the vehicle description. They said it
- 2 had blood on it, and a possible dent on the side, so we --
- 3 Tom Hutchins actually was the primary officer who physically
- 4 saw the vehicle, and I basically responded to his location.
- Okay. And when you-all responded, what happened,
- 6 did the vehicle stop obviously?
- 7 **A** We conducted a felony stop. I was the primary
- 8 officer who cut the vehicle off on Thompson and Orange
- 9 Avenue.
- 10 **Q** What do you mean you cut it off?
- 11 A Basically I went in front of it and stopped it
- 12 from proceeding. It was at a traffic light.
- Okay. And I am showing you State's 3, Composite
- 14 B1, B2 and B3. Is this -- what is this?
- 15 A It is an Acura TL series. Silver.
- 16 **Q** Is that the vehicle that we are talking about you
- 17 guys stopped?
- 18 **A** Yes, I identified that as the vehicle.
- 19 **Q** Roughly what time was it that the call went out
- 20 that there was an incident?
- 21 **A** Umm --
- 22 **Q** Do you need to refer to something?
- 23 A I probably need to refer to it.
- 24 **Q** If I showed you your report, would that assist you
- 25 in refreshing your memory?

- 1 A Yes. Definitely. Yes, it was.
- 2 Q Okay.
- 3 A Umm, approximately 0216 or 2:16 in the morning on
- 4 the 25th.
- 5 Q And approximately what time was it that this
- 6 silver Acura vehicle was stopped?
- 7 A I would say approximately ten minutes after,
- 8 within that time frame. The distance that it took him from
- 9 the incident of occurrence to the Thompson and Orange Avenue
- 10 location.
- 11 Q Now, once the vehicle was stopped, who was inside
- 12 the car?
- 13 **A** Mr. Dobbs and a female.
- 14 Q Okay. And can you just give a general description
- 15 of the female, white female?
- 16 A It was a -- I guess medium-colored black female.
- Okay. And who was driving the vehicle?
- 18 A Mr. Dobbs was driving.
- 19 **Q** And where was this black female?
- 20 A She was in the passenger side, front right.
- 21 **Q** I am sorry?
- 22 A She was in the front passenger side of the
- 23 vehicle.
- 24 Q Okay. And so what happened?
- 25 A Basically conducted a felony stop, had both the

- 1 driver and the passenger exit the vehicle.
- 2 Q Okay. And when you saw the vehicle, what -- what
- 3 did you observe of the defendant?
- 4 A The defendant had blood on him and he was pretty
- 5 excited, and you could see it in his face he was just kind
- 6 of in shock.
- 7 Q Okay.
- 8 A We had pulled him over because we assumed it was
- 9 the suspect vehicle that fit the description. Umm, there
- 10 was blood on the vehicle. It had an accident which they
- 11 described. You can see in the interior, there was blood on
- 12 the carpet itself, so we were pretty sure this was the
- 13 suspect. The defendant was then asked if he had any weapons
- in the vehicle and he replied, quote, yeah, yeah, I have a
- 15 gun. I have a knife and a gun in the vehicle.
- 16 **Q** Okay.
- 17 **A** Okay.
- 18 **Q** Did you locate the knife and the gun in the
- 19 vehicle?
- 20 **A** Yes. With his consent I asked him if we can
- 21 search his vehicle. He advised me that the knife was in the
- 22 center console and the gun was underneath the rear passenger
- 23 seat.
- 24 **Q** Okay.
- 25 **MS. LASKOFF:** If I could approach the witness,

- 1 Your Honor?
- 2 **THE COURT:** You may.
- 3 BY MS. LASKOFF:
- 4 **Q** I am showing you State's 6. Do you recognize this
- 5 item?
- 6 A Yes, I do.
- 7 **Q** And what is that?
- 8 A That was the folding knife that was wrapped in the
- 9 napkin full of blood.
- 10 **Q** Okay. Now, let me ask you about this. When you
- 11 saw it, did it -- it had blood on it, did it have -- there's
- 12 some dried blood on there, correct?
- 13 **A** Yes, there is.
- 14 **Q** Did it have more or less blood than this?
- 15 **A** There was more than that.
- 16 **Q** Did it look like it was dried like this, the
- 17 blood?
- 18 **A** No. No.
- 19 **Q** Did it look like it was wet?
- 20 **A** It was still wet.
- 21 **Q** Okay. And this was exactly where in the vehicle?
- 22 You said center console. Where is that center console
- 23 located in the vehicle?
- 24 A In between both, about arms rest or elbow. Right
- 25 at the elbow.

- 1 Q This is in the front seat between the front seat
- 2 and the passenger?
- 3 A Front seat between the front seat and passenger.
- 4 Q Okay. Now, if I can approach the witness, Your
- 5 Honor, I am showing you State's 5. Do you recognize what
- 6 this thing is?
- 7 A Yes, I do. It is a black high point C nine model,
- 8 nine millimeter.
- 9 Okay. Is this the gun that you located in the
- 10 defendant's car?
- 11 A Yes, it is. It should have the numbers scraped
- 12 off, the serial number.
- Okay. Where is it -- and it has been checked,
- 14 it's not loaded?
- 15 **A** Yeah, you can see where it is --
- 16 **Q** Can you show the jury where?
- 17 **A** Can I pick it up?
- 18 You can touch it. It has been processed.
- 19 A Serial number is located right in front.
- 20 Obviously you can't see from there, but the serial number is
- 21 scraped off.
- 22 Q Okay. Can you tell the jury exactly where in the
- 23 car was this gun located?
- 24 A It was directly behind his driver's side, the rear
- 25 passenger seat, just underneath his seat. You wouldn't be

- able to see unless he told you where it was. It was
- 2 actually, you had to lift up the seat cover, the seat
- 3 cushion to find it.
- 4 **Q** Just so we are clear, he's in the driver's seat?
- 5 \mathbf{A} Uh-huh.
- 6 Q Okay. Is it around his seat, is it under his
- 7 seat, is it over his seat?
- 8 A Behind his seat underneath the passenger.
- 9 Underneath the passenger side?
- 10 **A** Well, the rear passenger seat.
- 11 **Q** So underneath the back?
- 12 **A** Underneath that.
- 13 **Q** Somebody tucked it underneath something?
- 14 **A** It is tucked underneath.
- 15 **Q** What was it tucked under, a cushion?
- 16 A Just the seat cushion itself. It was forced into,
- in between the seat and the carpeting.
- 18 **Q** Okay.
- 19 **A** But there was a blood trail leading to it.
- 20 \mathbf{Q} To the gun?
- 21 **A** To the gun.
- 22 Q Okay. Now, you said that the defendant was
- 23 bleeding?
- 24 A Right. He had blood on him.
- 25 **Q** Okay. And was the woman bleeding?

- 1 A Not that I am aware of.
- 2 Q Okay. Now, you said he was excited when you
- 3 initially stopped him?
- 4 A Yeah. He was in like a state of shock.
- 5 Q Okay. And after the search of the vehicle --
- 6 **A** Uh-huh.
- 7 **Q** -- then what happened?
- 8 A We secured the weapons, both the handgun and the
- 9 knife and I turned over the weapon to Deputy Tom Hutchins.
- 10 He was, I guess, the primary deputy on the call itself.
- 11 **Q** Okay.
- 12 A The vehicle was later towed to Central Operations
- 13 4 for evidence.
- 14 **Q** Okay. Did you personally have any other
- 15 involvement in this investigation?
- 16 A Not at all. I was the -- just -- I was the
- officer who recovered the weapons and was turned over to
- 18 Deputy Hutchins.
- 19 **Q** Okay. Thank you.
- 20 **THE COURT:** You may proceed.
- 21 MS. VICKERS: Thank you.
- 22 CROSS-EXAMINATION
- 23 BY MS. VICKERS:
- 24 **o** Good afternoon.
- 25 **A** Good afternoon.

- 1 **Q** How are you doing?
- 2 A Good.
- 3 Q Good. Now, when you are at what you think is a
- 4 crime scene --
- 5 **A** Uh-huh.
- 6 Q -- do you alter or change anything around or do
- 7 you try to leave everything as is?
- 8 **A** We leave everything as is.
- 9 Q Okay. And did you give Mr. Dobbs an opportunity
- 10 to pull over or you guys just kind of cornered him off?
- 11 **A** We basically cornered him off.
- 12 **Q** So you didn't, like, turn on the lights and sirens
- 13 and wait?
- 14 A Oh, yeah, that we did, yeah.
- 15 **Q** Standard. And he pulled over?
- 16 A He was actually at a stop, at a red light.
- Okay. And he didn't try to run from you guys or
- 18 anything?
- 19 **A** Well, my vehicle was basically parked in front of
- 20 his, so he wouldn't be -- I mean, unless he rammed into
- 21 mine, he wasn't able to move.
- 22 Q Okay. And when you pulled him over, the windows
- in the car were rolled up?
- 24 **A** Yes, they were.
- 25 Q Okay. And did you alter that in any way --

- 1 **A** No.
- 2 from the time that the -- from you pulling him
- 3 over until the crime scene investigator came to take
- 4 pictures?
- 5 **A** No.
- 6 Q And were you on scene during that?
- 7 **A** Yes, I was.
- 8 All right. So nobody altered the windows?
- 9 **A** No.
- 10 **Q** And they were rolled up?
- 11 **A** Yes, I believe.
- 12 **Q** The entire time, I'm sorry, yes or no?
- 13 **A** Yes, it is.
- 14 **Q** Thank you.
- When you pulled Mr. Dobbs over, he was cooperative
- 16 with you-all?
- 17 **A** Yes, he was.
- 18 **Q** He told you exactly where the weapons were?
- 19 **A** Yes.
- 20 **Q** I mean, not only the fact that there were weapons?
- 21 A Right. He did tell me the location of the
- 22 weapons.
- 23 **Q** He told you exactly where they were?
- 24 **A** Yes.
- 25 And you said he was kind of in a state of shock?

- 1 A Right.
- 2 **Q** Looked like he had been in a fight?
- 3 A Possibly, yeah.
- 4 Q Okay. And the weapons when you found them both
- 5 had blood on them?
- 6 A Blood on them, yes.
- 7 Q Now, did you have a chance to talk with Mr. Dobbs?
- 8 **A** No.
- 9 **Q** Okay.
- 10 A Not after the fact. We were trying to secure the
- 11 weapons at first.
- 12 **Q** Okay. Now, did you notice his injuries that he
- 13 had?
- 14 **A** Umm, I believe he had a couple of cuts and
- 15 bruises, but I couldn't verify it exactly on his body. I
- 16 believe they were probably on his hands or, but I couldn't
- 17 verify it. I was basically, like I said, the officer just
- 18 recovering the weapons, securing them and turning them over
- 19 to the primary deputy on the scene.
- 20 Q Okay. If I were to show you a picture of
- 21 Mr. Dobbs, would that refresh your recollection as to his
- 22 injuries?
- 23 A Probably.
- 24 **Q** Okay.
- 25 MS. VICKERS: Your Honor, may I approach the State

- 1 and then the witness?
- 2 **THE COURT:** You may.
- 3 **MS. VICKERS:** May I approach?
- 4 **THE COURT:** You may.
- 5 **MS. VICKERS:** Thank you.
- 6 BY MS. VICKERS:
- 7 **Q** Now, if you will just take a look at these, hold
- 8 them down to where nobody else can see them, and then once
- 9 you're done -- I am showing you what has been marked as
- 10 Defense Exhibit H for identification. If you can just take
- 11 a look at those for me and let me know if that refreshes
- 12 your recollection when you're done?
- 13 A Umm, yes, all but one which is showing a possible
- 14 knee injury, which we didn't verify that.
- Okay. I am sorry. When you stopped Mr. Dobbs, he
- 16 was wearing long pants?
- 17 **A** Yes.
- 18 **Q** So you didn't notice any injuries to his legs?
- 19 **A** Right.
- 20 Q Okay. But you did notice injuries to his head and
- 21 face area?
- 22 **A** Yeah, that I can recollect.
- 23 And he had a large cut on his arm, is that
- 24 correct?
- 25 **A** Yes.

- 1 **Q** And then blood and kind of cuts on his hand?
- 2 A Yes.
- Now, at one point Mr. Dobbs almost passed out, is
- 4 that correct?
- 5 **A** I believe so, yes.
- 6 Q He laid down on the ground?
- 7 A He needed to, I guess, hold himself against the,
- 8 his vehicle or our vehicle I believe. Actually, I believe
- 9 it was our vehicle. He needed to lean on the vehicle.
- 10 **Q** Okay. Because he felt faint or was going to pass
- 11 out?
- 12 **A** Yeah.
- 13 Q And was he allowed to lean on something so he
- 14 wouldn't injure himself further?
- 15 **A** Yes, of course.
- 16 **Q** All right.
- 17 MS. VICKERS: I don't have anything further.
- 18 **THE COURT:** Any redirect?
- 19 **REDIRECT EXAMINATION**
- 20 BY MS. LASKOFF:
- 21 **Q** Deputy Mercado, he was treated by paramedics,
- 22 correct?
- 23 **A** Yes, I believe so.
- 24 Q Okay. Did they respond to the scene, to the

| 6 | DIRECT EXAMINATION |

| 8 | Q Can you introduce yourself to the jury and tell |
| 9 | them your name? |
| 10 | A Dorinda Blaney. |
| 11 | Q And Ms. Blaney, where do you work? |
| 12 | A I work with the Orange County Sheriff's Office. |
| 13 | Q And what is your assignment there? |
| 14 | A I am a latent print examiner. |
| 15 | ${f Q}$ Okay. How long have you worked at the sheriff's |
| 16 | office? |
| 17 | A Just over 17 and a half years. |
| 18 | Q Okay. Just over? |
| 19 | A Correct. |
| 20 | Q Okay. Now, as a latent print examiner, what |
| 21 | training have you had in order to become a latent print |
| 22 | examiner? |
| 23 | A I have taken a 40 hour class given by the FBI on |
| 24 | fingerprint comparisons. I have attended a 40 hour class |
| 25 | given by the FBI in advanced comparison, a 24 hour symposium |

- on palm print comparison. I attended a 40 hour course given
- 2 by the International Association of latent comparisons. I
- 3 have attended approximately four 40 hour training
- 4 conferences. I have job shadowed in my position for a year
- 5 before I received the position.
- 6 Q And do you annually do training to keep current on
- 7 things?
- 8 A Umm, normally I try to attend a conference every
- 9 couple of years.
- 10 **Q** Okay. And let me ask you this, what, as a latent
- 11 print examiner at the sheriff's office, what are your duties
- 12 and what is it that you have to do?
- 14 our office by a forensics unit and our road deputies. It is
- our job to evaluate those to see if they are comparable
- 16 value or not. If they are, we compare them to possible
- 17 suspects, victims, witnesses at the discretion of the
- 18 detective. We also identify deceased individuals requested
- 19 from the morgue's office and we assist any other law
- 20 enforcement agency at their request.
- 21 **Q** Okay. Do you have special equipment that you
- 22 utilize in your position?
- 23 **A** The main thing is a small magnifying glass.
- 24 **Q** Okay.
- 25 MS. LASKOFF: Your Honor, at this time the State

- would tender Ms. Blaney as an expert in fingerprint
- analysis and comparisons.
- 3 **THE COURT:** Any voir dire?
- 4 MS. CHIEN: No, Your Honor.
- 5 **THE COURT:** Any objection?
- 6 MS. CHIEN: No, Your Honor.
- 7 **THE COURT:** This witness will be able to render
- 8 her opinion in that area.
- 9 BY MS. LASKOFF:
- 10 **Q** Now, I am going to show you State's Exhibit 8. Do
- 11 you recognize what this is?
- 12 **A** Yes, I do.
- 13 **Q** And how is it that you recognize what that is?
- 14 A I signed a latent receipt form submitted by our
- 15 forensics unit.
- 16 **Q** And can you tell the jury what is that?
- 17 **A** This is our latent envelopes that our deputies
- 18 submit the latents to our office in and they put the latents
- 19 that they process from a crime scenes within those
- 20 envelopes.
- 21 \mathbf{Q} And specifically this is a latent fingerprint from
- 22 what?
- 23 **A** This is a photo of a latent fingerprint off of a
- 24 razor blade.
- 25 **Q** And did you do any testing on this, or analysis?

- 1 A I evaluated the latent that was submitted to see
- 2 if there was anything of comparable value on it.
- Okay. And when you did this evaluation, what were
- 4 your findings?
- 5 **A** That there was no significant detail there for
- 6 comparison purposes.
- 7 And what -- for the rest of us, what does that
- 8 mean?
- 9 A That means there is not enough ridge detail or
- 10 points of identification that I can use to identify to
- 11 somebody.
- 12 **Q** Okay. So there is just not enough of a print on
- 13 there?
- 14 A Correct.
- Okay. So is there a way to make it so that you
- 16 could have compared to something?
- 17 **A** No.
- 18 **MS. LASKOFF:** I have nothing further, Your Honor.
- 19 **THE COURT:** Any cross-examination?

| 8 | lab for latent prints. I also compare prints from known |

| L7 | MS. CHIEN: Yes, Your Honor. |
| L8 | THE COURT: Is there such a stipulation? |

| 22 | MS. LASKOFF: Yes, ma'am. |
| 23 | BY MS. LASKOFF: |
| 24 | O Ms. Gabriel, did vou become involved in a case |

let me ask you this. FDLE case number 2006-0514280?

- 1 A Yes, I did.
- 2 Q Okay. And can you explain to the jury basically
- 3 what is the process that FDLE gets evidence?
- 4 A The process where we get our evidence submitted to
- 5 the lab is that either it is mailed in, or the agency sends
- 6 someone to the lab to drop the evidence off. It comes
- 7 through our evidence intake section. They will make
- 8 folders, complete the paperwork, and assign our lab case
- 9 number to that case. After the files have been made up for
- 10 each section whether the evidence is to be processed or
- 11 looked at for whichever examination the agency requests, the
- 12 evidence is maintained in the vault. When the evidence is
- 13 ready to be processed, it is then transferred to an analyst
- 14 in order to do their examination.
- Now, how do you make sure, say, for example, in
- this case what somebody submits, doesn't get mixed up with
- 17 another case?
- 18 **A** Each piece of evidence that comes into our lab is
- 19 assigned a laboratory case number along with a bar code that
- 20 has identifying case numbers, evidence container numbers, as
- 21 well as the agency name on that bar code label.
- 22 Okay. And then what happens once it is placed
- 23 into the evidence section at the Florida Department of Law
- 24 Enforcement, how does it get up to you?
- 25 **A** It is transferred to me through our computer

- 1 system so each piece of evidence is tracked and we know
- which person has it, which section that piece of evidence is
- 3 in.
- 4 Q And when you say which section, what do you mean
- 5 by that?
- 6 **A** We have several sections within the Florida
- 7 Department of Law Enforcement at our lab to process or
- 8 analyze evidence. We have our biology section, our latent
- 9 print section, our chemistry section, our firearms section
- 10 as well as our drug and toxicology section and our trace
- 11 microanalysis section.
- 12 **Q** Okay. Now, did you receive evidence pertaining to
- 13 this case?
- 14 A Yes, I did.
- 15 **Q** And what evidence is it that you received?
- 16 **A** The evidence I received in this case was a qun, a
- 17 gun magazine, some live rounds and also a knife.
- 18 **Q** Okay. Was there a razor blade too? Did you
- 19 receive the razor blade?
- 20 A No, ma'am, I did not receive a razor blade.
- 21 Q Okay. And when you received these items, what
- 22 happens?
- 23 A When I received these items, they were all in a
- 24 sealed container. I had to open up the evidence in order to
- 25 process and document what I was going to process for latent

- 1 prints.
- 2 Now, when you say you processed them, what does
- 3 that entail? How do you process something?
- 4 A When I process evidence, the latent prints, I am
- 5 looking at it visually. Also I use a light source,
- 6 chemicals and powders in order to make the latent prints
- 7 visible to the naked eye.
- 8 Okay. I am going to show you what has been marked
- 9 as State's Exhibit 6. Do you recognize this? I'm also
- 10 going to show you State's Exhibit 5. If you can look at
- 11 that I will put it over here. Do you recognize what that
- 12 item is, the first one I handed you?
- 13 A Yes, I do, and this exhibit in this box was a
- 14 pocket knife, a folding knife that I processed for latent
- 15 prints.
- 16 **Q** And when you processed it, what happened?
- 17 **A** I wasn't able to develop or see any latent prints
- 18 on it.
- 19 Q Okay. And bare with me. I forgot what this item
- 20 number is, Exhibit 5. If you can look at those, it is a
- 21 composite as well?
- 22 A Yes, I did process this evidence also for latent
- 23 prints.
- 24 And how about the item in a box?
- 25 **A** Yes, I also processed this gun for latent prints.

- Okay. And I forgot to ask you, how do you know
- these are the items that you processed, if you could explain
- 3 that to the jury?
- 4 A Yes, ma'am. I recognize these items that I
- 5 processed for latent prints from our bar code label and also
- 6 from my initials. Each time I put my initials on them as
- 7 well.
- 8 Q Okay. Now, how do you make sure that these items
- 9 doesn't get your prints or someone else's prints mixed up on
- 10 them once they are submitted into evidence?
- 11 A When I am processing the evidence for latent
- 12 prints, I do wear gloves.
- Okay. And are there certain procedures in place
- 14 to ensure that other people don't accidentally mix it up and
- 15 get their prints on it?
- 16 **A** Yes, ma'am. What we normally do is we have our
- 17 evidence separated from any other evidence so that the
- 18 evidence that I have in one of our processes, our tanks to
- 19 process evidence, that would be my particular tank for my
- 20 evidence.
- 21 **Q** Okay. Can you tell the jury on Exhibit 5, the gun
- 22 and the magazine and the live rounds as well as the pocket
- 23 knife, were you able to find any latents on these items?
- 24 A Using the processes that I use on these pieces of
- 25 evidence, I was not able to see or develop any latent prints

- 2 Q Okay. Does that mean nobody ever touched these
- 3 items?
- A No, ma'am, there are a number of reasons why
- 5 latent prints may not be left on the evidence. Some of
- 6 these factors include where the evidence was left.
- 7 Sometimes when it is left in an environment, the rain, the
- 8 heat, the humidity, the dust can destroy latent prints.
- 9 Also, excessive handling of evidence can destroy latent
- 10 prints. Sometimes gloves may be worn. Sometimes prints are
- 11 wiped off. Other times there may not have been enough
- 12 contaminants on the hands to leave good latent prints.
- 13 **Q** Okay. Did you have any other forensic analyses
- 14 that you did yourself on any items involved in this case?
- 15 **A** No, ma'am. The only analysis I did on this
- 16 evidence was for latent prints.
- 17 **Q** Okay.
- 18 MS. LASKOFF: I have nothing further for this
- 19 witness, Your Honor.
- 20 **THE COURT:** Cross-examination?
- 21 MS. CHIEN: Your Honor, may we first approach?
- 22 **THE COURT:** You may.
- 23 (Conference at the Bench held on the record.)

- 16 **Q** Ma'am, can you introduce yourself to the jury and
- 17 tell them your name.
- 18 A Yes, my name is Jillian White.
- 19 **Q** And Ms. White, where do you work?
- 20 A I work for the Florida Department of Law
- 21 Enforcement as a crime laboratory analyst in the biology
- 22 section.
- 23 **Q** Okay. And what are your duties there in that
- 24 section?
- 25 **A** As a forensic analyst, what I do is I screen items

- of evidence for the presence of body fluid such as blood,
- 2 semen and saliva and then once I find them, I try and
- 3 determine who possibly donated those things.
- 4 Q Okay. And specifically to be a forensic analyst
- 5 for the biology section, what schooling did you attend prior
- 6 to going to the Florida Department of Law Enforcement?
- 7 A I have my Bachelors of science from the University
- 8 of Central Florida in micromolecular biology. I also just
- 9 completed a one year training program to become an analyst
- 10 with the Florida Department of Law Enforcement in the
- 11 biology section.
- 12 Q Okay. And this one year training, what does that
- 13 entail?
- 14 A Basically it is divided into two phases. The
- 15 first phase I go through extensive readings, test taking,
- 16 two oral boards of everything that I have to learn and I
- 17 have to do practical samples. Once I complete that, I go
- into phase two training, which basically I work underneath
- 19 an analyst and I do supervised case work just like I would
- 20 be working a normal case and then upon completion I take a
- 21 qualifying test to show that everything I have done I am
- 22 qualified to work as an analyst in the biology section.
- 23 Q Okay. Now, in this qualifying test, do you -- you
- have certain proficiency tests to check for accuracy
- 25 throughout your career, still?

- 1 A Yes, the qualifying test is actually just like
- 2 proficiency tests that we are required to take twice a year
- and that just shows that it comes from an outside source.
- 4 We do not know any of the answers to the test, and we screen
- 5 it just like we would work normal case work and then submit
- 6 those samples back to that outside agency and then we work
- 7 it just like we work it, and we are required to take a
- 8 proficiency test twice a year.
- 9 Now, is the lab at the department, the Florida
- 10 Department of Law Enforcement, accredited?
- 11 A Yes, we are actually an accredited based CLAD lab
- 12 and what that stands for is the American Society of Crime
- 13 Laboratory Directors Laboratory Accreditation Board.
- 14 And why should the jury even care about that?
- 15 **A** Well, basically by being accredited, we show that
- 16 we can meet certain guidelines and standards set forth so
- 17 that way, you know, the quality that comes from us meets
- 18 these guidelines, the quality of our work, all of our
- 19 procedures that we perform are screened and they are looked
- 20 over to make sure they meet quality and that all of the, how
- 21 we perform our tests and the work that is generated by the
- 22 analysts meet these guidelines.
- 23 Okay. Can you tell the jury what is DNA? I mean,
- 24 we've all heard DNA, DNA, but specifically, what is it to
- 25 one of us lay folks?

- 1 A What DNA stands for is deoxyribose nucleic acid
- 2 and basically it is the genetic blueprint that is found in
- 3 our entire body, all the cells in our body. It is
- 4 determined during conception. When you inherit one set from
- 5 your mother, and one set from your father and your DNA is
- 6 the same throughout your entire body, so the DNA in your
- 7 saliva is the same as the DNA in your blood, in your skin
- 8 cells and in your hair.
- 9 Q Okay. Now, how is DNA used and utilized in the
- 10 study of forensics?
- 11 **A** Well, what we try and do is -- the type of testing
- 12 I perform is called STR testing or short tandem repeats and
- 13 what that means is that since we are all human, much of our
- 14 DNA is the same, gives us two eyes, two ears, two arms. But
- there's a very small percentage of our DNA that's actually
- 16 different which makes us unique. And that small area is
- 17 what I am actually interested in. And out of that area I am
- 18 looking at 13 different areas of that to see how many times
- 19 it repeats.
- For instance, I'm looking to see how many times
- 21 the word CAT is repeated at one area, so I am looking for C
- 22 A T, C A T, C A T. And if you remember, I said we'd get two
- 23 sets, one from our mother, one from our father, so at one
- 24 area I am looking, I may have a repeat of a seven and a nine
- 25 whereas you may have a repeat of a 10 and 11. So now I have

- 1 13 areas that I go through and I look at to see how many
- 2 repeats at each area and this is how we develop a person's
- 3 DNA profile. And on top of these 13 areas, I also have one
- 4 area that lets me know whether or not it is a male or a
- 5 female.
- 6 Q Okay. Now, let me ask you, the DNA testing that
- 7 you do at the lab, can you just briefly describe what the
- 8 process is that you utilized?
- 9 A What I do is, first I need to, when I screen my
- 10 items of evidence, I visually look for the presence of a
- 11 particular stain, and then what I have is I have very simple
- 12 chemical tests that I can do to determine if a stain is
- 13 present. If I do find something, I take a small portion of
- 14 that stain, I put it in a tube. I just apply some heat and
- 15 chemicals to break open the cells to get the DNA out. Once
- 16 I have the DNA, I need to determine how much of the DNA is
- 17 there.
- 18 From that I then go -- I take it and then I need
- 19 to multiply it, like xerox it many times so I will take a
- 20 little and make much more. Once I have xeroxed the DNA or
- 21 replicated the DNA, I then put it on an instrument which
- 22 helps me separate the DNA based on size and it will separate
- 23 it out for these 13 areas. And what I am looking at is that
- 24 each area I look to see what the number of repeats, like I
- 25 spoke earlier at each area is, and that's just basically

- 1 what I am doing.
- 2 Q Okay. Now, in this whole process, do you have
- 3 certain controls to make sure your blood or other cases
- 4 blood doesn't get mixed up somehow in the specific case you
- 5 are doing, testing items on?
- 6 A Umm, throughout our entire process, we use
- 7 controls the entire time. And every time we add to a
- 8 different step of the process we add more controls. So that
- 9 way we can make sure that each step is performed the way
- 10 that it should be and we use what is called both positive
- 11 controls that we expect to get a certain result and we use
- 12 negative controls to make sure no contamination had happened
- 13 at those steps. So we utilize a lot of controls so that way
- 14 we can make sure that everything is working as it should.
- Okay. And have you ever testified in a court
- 16 before as an expert?
- 17 A No. This is actually my first time. I have never
- 18 been called before this.
- 19 Okay. How many times have you done DNA testing?
- 20 **A** I have done it many times. I have done it over a
- 21 thousand times. Over a thousand samples I have worked.
- 22 **Q** Okay.
- 23 MS. LASKOFF: Your Honor, at this time the State
- 24 would render, ask permission from the Court for
- 25 Ms. Jillian White to be permitted to offer opinion

- testimony in the area of forensic serology.
- 2 **THE COURT:** Any voir dire?
- 3 MS. CHIEN: No, Your Honor.
- 4 **THE COURT:** Any objection?
- 5 **MS. CHIEN:** No, Your Honor.
- 6 **THE COURT:** She will be permitted to render
- 7 opinion testimony.
- 8 MS. LASKOFF: Thank you, Your Honor.
- 9 BY MS. LASKOFF:
- 10 **Q** Now, let's talk specifically about FDLE case
- 11 number 2006 0514280. Okay. Were you one of the analysts
- 12 involved in this case?
- 13 **A** Yes.
- 14 And what were you asked to do on this case?
- 15 A Umm, I had items submitted to me and I was asked
- 16 to perform DNA analyses on those items.
- 17 Okay. And did you receive -- what were those
- 18 specific items that you received, do you recall?
- 19 A I received three submissions. On my first
- 20 submission I -- did you want me to kind of list all of this
- 21 stuff or?
- 22 **Q** Well, let me ask you this. Let me show you,
- 23 approach you with Exhibit 6. Is this one of the items that
- 24 you received?
- 25 **A** Yes, it is.

- 1 Q And how do you know that's one of the items that
- 2 you received?
- 3 A Umm, by the FDLE case number and my initials.
- 4 Q Okay. And what is that item?
- 5 **A** Item 06. This is a knife.
- 6 Q Okay. Now, I am going to show you Exhibit 5. Do
- 7 you recognize this item?
- 8 **A** Which one are you referring to?
- 9 **Q** The large one, it is a composite.
- 10 **A** The Q7, yes. This is Q7.
- 11 **Q** And that is?
- 12 **A** This I have as a high point model C9 9-millimeter
- 13 Ruger gun.
- 14 Q Okay. And how do you know that's one of the items
- 15 that you --
- 16 A Again, by the FDLE number and my initials.
- 17 Q Okay. I am going to approach you with State's
- 18 Exhibit 9. Again, the same question, is this one of the
- 19 items you received, and if so, how do you recognize that
- 20 item?
- 21 **A** I have this as Q9, a swab from a razor blade and
- 22 again, by my -- oops, the FDLE label and my initials.
- 23 **Q** I'm going to show you Exhibit 10 and Exhibit 12,
- 24 if you could individually look at those. And are these as
- 25 well the items that you received, and if so, how do you know

- 1 that, in fact, those are the items that you received?
- 2 A The first one, the container one, which is K1,
- 3 which is, to me is buccal swabs represented as being from
- 4 John Dobbs and again, because of the FDLE number and my
- 5 initials. And then the next one, which is, I guess Exhibit
- 6 10, container 3, which is to me K3, which is a DNA card
- 7 represented as being from William Troy, again by the FDLE
- 8 number and my initials.
- 9 Let me first ask you, when you tested these items,
- 10 what did you do to prepare them for analysis? Do you want
- 11 to go one by one with the main items?
- 12 **A** Sure. Which one would you like me to start with?
- 13 **Q** If you want to start with -- specifically, let's
- 14 talk about the gun and then we can talk about the knife and
- then we can talk about the razor blade swab. Okay?
- 16 A Okay. So for the gun, what I did first is I
- 17 looked for -- I visually examine it for, you know, I'm
- 18 looking for potential blood, so I am looking for any red
- 19 brown staining and I did find some, so I have a chemical
- 20 test that I need to see if it could possibly be the presence
- of blood and it is a very simple chemical test where I just
- 22 rub a piece of filter paper, apply a couple chemicals and I
- look for an immediate pink color, and in this case it did.
- 24 I did get a pink color which tells me that this could
- 25 possibly be blood, and then from there I swabbed the stain

- 1 to take a portion of that onto DNA to do my DNA analysis
- 2 that I explained a little bit earlier.
- Okay. And then at that point what did you do with
- 4 the gun, with the testing on the gun I should say?
- 5 A Umm, after -- well, once I run it through my DNA
- 6 analysis, I then look at my results to see what all I got,
- 7 and what I obtained on that swab is I obtained the presence
- 8 of a mixture of two or more individuals, and basically what
- 9 the mixture is, is if you remember before, I told you that
- 10 we each have two pieces of DNA, one from our mother and one
- 11 from our father. So, if I happen to see three pieces or
- 12 four pieces or more, that tells me that there's more than
- one individual there. And in this instance, I saw a mixture
- 14 of two or more individuals which told me that there is at
- 15 least five or six pieces there. And so, then what I do is I
- 16 try and determine whether or not I can separate those pieces
- 17 out to see if I -- who all could be contributing to this and
- 18 I was able to get a major profile. I had enough to be able
- 19 to get a major profile out of it, and then I also had minor
- 20 contributors to this mixture.
- 21 **Q** Okay. Let me ask you about that. Minor profile
- versus major profile, what does that mean to us?
- 23 **A** Well, basically if you remember I said that when
- 24 we do our separation, it is based off size and at -- just
- 25 basically talking at one area. And I have different,

- 1 different peaks and stuff. We have -- what we look at is
- 2 how high each peak is and so if I may have a peak that is
- 3 like a thousand unit high versus a peak that is 100 unit
- 4 high, so, I know that the thousand, a peak that is a
- 5 thousand unit high cannot go with the peak that is 100,
- 6 because it's not equal in value. So, what we do is the one
- 7 that's a thousand has more DNA present than the one of the
- 8 minor that only has 100, and so I can go through each 13
- 9 areas and pull out what we call is the major contributor to
- 10 this particular stain to be able to determine a profile.
- 11 **Q** Okay. And in this case you indicated that you
- 12 found a major contributor of a DNA profile?
- 13 **A** Yes.
- 14 **Q** And that was of whom?
- 15 **A** Umm, the major contributor matched that of John
- 16 Dobbs.
- 17 Okay. And let me ask you this, just so the jury
- 18 understands, did you utilize the samples from the buccal
- 19 swabs in the processing of the gun to reach that decision?
- 20 **A** What I do with what these are called for us are
- 21 standard for reference samples, which we know that they come
- 22 from an individual, and so what I do is I do the same type
- 23 of testing like I do on my unknown samples, go through the
- 24 process and I get a profile, but what I do, once I have my
- 25 unknown and I have my sample, and I have this -- in this

- 1 case it was their major contributor, I then look at all of
- 2 my standards from everybody to see who matches this major
- 3 contributor of this mixture. And what we do is we go
- 4 through all 13 areas to see, make sure that all the repeats
- 5 match. If at even one area it does not match, like if it
- 6 only matches 12 of the 13, that person does not contribute
- 7 to this. They have to match at all 13 areas.
- 8 Q Could you, and I, for example, maybe match in some
- 9 areas?
- 10 A We can share -- like I said before, like I could
- 11 have a repeat of a 7 and a 9 where you could have a repeat
- 12 at a 7 and 9 at that one area but at the other 12, they
- 13 would be distinctly different.
- 14 **Q** Okay. Now, the minor contributor, what was your
- 15 finding with regard to the minor contributor on the gun?
- 16 **A** With this particular one, because it was of a
- 17 mixture of two or more individuals as far as comparing --
- 18 remember I always said we compare peak heights and stuff,
- 19 the more individuals you get in there, it is very hard to
- 20 make any kind of comparison to keep to match up these
- 21 heights between individuals. The reason I was able to pull
- 22 out this major is because it was distinctly different from
- 23 the rest, but the minor I couldn't do any determination on.
- 24 And basically all I can say is that I can look at my other
- 25 standards to see who all could possibly have contributed to

- this, the remaining minor, you know, and not be excluded.
- 2 Q Okay. And so did you make that finding on who
- 3 would be a minor?
- A As far as the minor, the sample I had from William
- 5 Troy cannot be excluded as a possible contributor to this
- 6 minor mixture.
- 7 Q Now, simply because he cannot be excluded, is
- 8 that, based on your forensic training, conclusive evidence
- 9 that he touched the gun or held the gun?
- 10 A Umm, basically all I can say is that what I found,
- 11 because it cannot be conclusively determined that he had
- something of the alleles there, or the areas that matched so
- 13 I had, he could contribute to it. Maybe I am not
- 14 understanding where you are going.
- Okay. Well, let me ask you a different way.
- 16 William Troy cannot be excluded from the DNA on the gun.
- 17 You are saying he's possibly a minor contributor to the DNA
- 18 on the gun, correct?
- 19 **A** Correct.
- 20 Q Okay. And is that saying to the jury simply
- 21 because he can't be excluded that he necessarily came into
- 22 contact personally with the gun? Does it make sense that
- 23 way?
- 24 **A** Umm, because of there being, I guess, the possible
- 25 presence of blood there, just by simply, you know, handling

- 1 it or something. What we are looking for is the presence of
- 2 cells, and a significant amount to be able to get something.
- 3 So I would expect as far as just maybe, I don't know,
- 4 touching it because our hands don't, you don't really sweat
- 5 that much. Everybody is different. Especially the palms of
- 6 the hand don't slough that much cells off of that. So for
- 7 something like that, it would be kind of highly unlikely
- 8 that it would be more from just a holding or significance of
- 9 just coming into contact versus leaving a little bit more
- 10 you know, of a -- more of a significant stain like that
- 11 could come from that because I did see red brown staining.
- 12 **Q** Okay. Well, how is that different where you
- indicate in your report that the major contributor matches
- 14 the defendant, John Dobbs, is that different? Your finding
- in that regard of him handling the gun, is it more of an
- 16 indicator because he is a major contributor, the defendant,
- that he possibly handled the gun versus the other individual
- 18 who's a minor possible contributor?
- 19 A Basically because of the major, there was more DNA
- of the major there. So there was more DNA left from the,
- 21 from John Dobbs because he's the major versus the minor of
- 22 William Troy possibly being the contributor to this minor,
- 23 so there was more of a DNA left by that. I mean, what I was
- testing was, in this case, was a red brown stain which we
- 25 would say is possibly for the presence of blood. So, with

- 1 the amount of the red brown stain -- I don't know if I am
- 2 answering it.
- 3 **O** You can finish.
- 4 A So it is kind of -- from it -- like if I would be
- 5 testing just, like -- I didn't test the grip or anything as
- 6 far as holding or whatnot. Like the area that I was testing
- 7 was this red brown stain. So more of what I would expect
- 8 would be coming from, you know, the blood, or the possible
- 9 presence of blood versus just brushing something, and having
- 10 cells left there if that's what you are kind of asking me.
- 11 **Q** Yeah. Well, let me ask you this, was it like a
- 12 droplet or was it the entire side of the gun?
- 13 **A** Umm, the area that I tested, it was kind of like a
- 14 smear on the side of the gun. And it was visible red brown
- 15 staining.
- Okay. Now, let me take you to the knife.
- 17 **A** Okay. Uh-huh.
- 18 **Q** Which is the next piece of evidence. It is
- 19 State's 6. Okay. And can you indicate to the jury what
- 20 testing you did? Was it the same as you did on the gun?
- 21 **A** Yes, it was. Again, I am looking for the presence
- of red brown staining, so I did a visual exam and I did a,
- 23 again, that same very simple color test, which was a
- 24 positive reaction for the possible presence of blood. Then
- 25 I swabbed an area of the knife to take that on for DNA

- 1 testing, and then I obtained my results.
- 2 Q Okay. And what are your results?
- 3 A From the -- I did indicate the presence of a
- 4 mixture, again, of two or more individuals, and I was able
- 5 to determine a major contributor, and this -- the major
- 6 contributor from this matched that of William Troy.
- 7 Where on the knife was it that you were testing
- 8 the blood?
- 9 A I believe I swabbed the area of -- I swabbed the
- 10 area of the upper blade. I had to be very careful because
- 11 when I received this evidence, there's not just my section
- that can be requested to work up, and so if there's other
- 13 sections like latents or chemistry or toxicology that happen
- 14 to need to look at this, we have to kind of be respectful,
- so we don't potentially damage stuff for other sections.
- 16 So, to not potentially interfere with another section, as
- far as I could only kind of swab the top of it, just so I
- 18 could receive other oh, potential evidence intact for other
- 19 sections.
- 20 Q Okay. But William Troy was the major contributor
- 21 on the portion of the blade that you tested?
- 22 **A** That is correct.
- 23 Okay. Now, if you could, the next is the swab
- 24 that was submitted from the razor blade. It is State's 9.
- 25 **A** Uh-huh.

| 3 | A | Again, I was looking for the possible presence of |
| 4 | blood, and | d in this case my color test came back negative. |

| 14 | | CROSS-EXAMINATION |
| 15 | BY MS. CH | CEN: |
| 16 | Q | Good afternoon. The items that you tested in this |
| 17 | case, you | received them from the Orange County Sheriff's |
| 18 | Office, co | orrect? |
| 19 | A | Yes. |
| 20 | Q | And Orange County Sheriff's Office, they selected |
| 21 | the items | to be tested, is that correct? |
| 22 | A | Yes. |
| 23 | Q | Okay. And Orange County Sheriff's Office did not |
| 24 | send any s | swabs of blood that was found on the Acura, is that |

correct?

- 1 A No, I did not receive anything.
- 3 send any blood found at the scene to be tested, is that
- 4 correct?
- 5 **A** Not that I have.
- 7 **A** That is correct.
- 8 **Q** All right. So Orange County Sheriff's Office they
- 9 picked the items to be tested, correct?
- 10 A That's whatever they submitted to me.
- Okay. And you can't tell how the DNA gets on
- 12 these items?
- 13 A No, I cannot.
- 14 You also tested some clothing, is that correct?
- 15 **A** Yes, I did.
- 16 And the clothing that was submitted to you by the
- 17 Orange County Sheriff's Office, all of that clothing
- 18 belonged to John Dobbs?
- 19 **A** That is correct.
- 20 Q Okay. Now, let's take -- let's talk about those
- 21 items, specifically let's talk about the jeans that belonged
- 22 to Mr. Dobbs. That came back positive for the presence of
- 23 blood, is that correct?
- 24 **A** Yes, that is correct.
- 25 **Q** And you, I guess, analyzed the section, I guess

- 1 stain A, and the major contributor of that blood belonged to
- 2 Mr. Dobbs, is that correct?
- 3 A Yes.
- 4 Q And you could not exclude Andre Blanco and
- 5 Fransisco Gotay's blood on that stain as well?
- 6 **A** That is correct.
- 7 **Q** Now, the stain on the jeans you found, you picked
- 8 another part of the jeans to test, is that correct?
- 9 A Yes.
- 10 And it was -- and you found DNA that belonged to
- 11 John Dobbs; is that correct?
- 12 **A** That is correct.
- 13 **Q** And on those same jeans you selected another area
- 14 to test, is that correct?
- 15 **A** Yes.
- 16 **Q** Stain F?
- 17 **A** That is correct.
- 18 **Q** And the major contributor was John Dobbs, is that
- 19 correct?
- 20 **A** Yes.
- 21 **Q** And you could not exclude -- that was a mixture as
- 22 well, there was a mixture there, is that correct?
- 23 **A** Yes.
- 24 And William Troy, he could not be excluded as a
- 25 possible contributor to that DNA, is that correct?

- 1 **A** That is correct.
- 2 Q You also found another stain, stain I; is that
- 3 correct?
- 4 **A** That is correct.
- 5 And a major contributor of that DNA was Andre
- 6 Blanco, is that correct?
- 7 **A** That is correct.
- 8 Q And you could not, the minor, the minor
- 9 contributor, he could have -- William Troy could have been a
- 10 minor contributor to that stain as well, is that correct?
- 11 **A** In this instance, because it was a mixture of two
- 12 or more -- I am sorry, I can't answer that just with a yes
- 13 or no. May I just explain just a bit?
- 14 **Q** Sure.
- 15 A Okay. In this instance, it was a mixture of just
- 16 two individuals versus the other ones, having a mixture of
- 17 two or more individuals. So because I could look at the
- 18 peak heights of how it is and separate it out, I was -- and
- 19 I had -- I obtained more information out of this particular
- 20 stain. So the major one I could contribute to Andre Blanco,
- 21 and the minor one matched William Troy at those areas, and
- 22 so he's more -- it is not just he could not be excluded. I
- 23 was able to actually get areas for each one, separate them
- out for each, for both the major and the minor, so I was
- 25 able to actually get a profile at some of these areas that

- 1 actually matched each individual.
- 2 Q Okay. So, William Troy, he could be a possible
- 3 contributor; is that correct?
- 4 A He matched as far as the minor contributor. He
- 5 did match three of those areas because I did have more
- 6 information, so he did match three and he was also included
- 7 at the remaining of the 13.
- 8 Q Okay. Now, you also tested another section of the
- 9 jeans, stain I; is that correct?
- 10 **A** That was stain I?
- 11 **Q** Well, under stain I, John Dobbs was the major
- 12 contributor, correct?
- 13 A Under stain I, Andre Blanco was the major and
- 14 William Troy was the minor.
- 15 **Q** I am sorry, J. You picked another section and you
- 16 also -- and John Dobbs was the major contributor to the
- 17 blood that was found, is that correct?
- 18 **A** That is correct.
- 19 And let's talk about this shirt that was
- 20 represented to you as belonging to John Dobbs. You found
- 21 blood on his shirt, is that correct?
- 22 **A** That is correct.
- 23 And you tested certain stains, about seven stains
- 24 I have?
- 25 **A** Yes.

- 1 Q And the first three stains, the DNA that was found
- 2 from the blood matched John Dobbs, is that correct?
- 3 A That is correct.
- 4 Q You also found on the other stains, on stain F,
- 5 that it matched Andre Blanco, is that correct?
- 6 **A** That is correct.
- 7 Q So, Andre Blanco's DNA was on Mr. Dobbs shirt, is
- 8 that correct?
- 9 A Yes.
- 10 You tested another section, section E, and the
- 11 major contributor was John Dobbs, is that correct?
- 12 **A** Yes, it is.
- 13 And on stain K, the major contributor was John
- 14 Dobbs again?
- 15 **A** That is correct.
- 16 And you could not exclude Andre Blanco and William
- 17 Troy as possible minor contributors to the DNA; is that
- 18 correct?
- 19 **A** That is correct.
- 20 Now, on the tank top that was represented to you
- 21 belonging to John Dobbs, there was also blood on that, is
- 22 that correct?
- 23 **A** That is correct.
- 24 And that blood matched John Dobbs, is that
- 25 correct?

- 1 **A** That is correct.
- 2 **Q** When you were talking about the knife, you
- 3 couldn't determine the minor contributors as far as like the
- 4 blood on that, on the knife, is that correct?
- 5 **A** That is correct. Well, may I explain just a bit?
- 6 Well, I am sorry --
- 7 Q Umm, well, you couldn't determine exactly who was
- 8 on the minor contributor, is that correct?
- 9 **A** (pause).
- 10 You just couldn't exclude certain people?
- 11 **A** That is correct.
- 12 **Q** So it is possible and you could not exclude John
- 13 Dobbs, is that correct?
- 14 **A** That is correct.
- 15 **Q** And you couldn't exclude Fransisco Gotay?
- 16 **A** That is correct.
- 17 **Q** Andre Blanco?
- 18 **A** That is correct.
- 19 **Q** Let's talk about the gun. You can't exclude
- 20 William Troy as a possible contributor on the gun, is that
- 21 correct?
- 22 **A** That is correct.
- 23 **Q** So there was blood found on the gun, and that
- 24 blood could have belonged to William Troy, is that correct?

- 1 did get the mixture. The major belonged to John Dobbs, and

- 3 to get any of a profile, but of what areas of what showed

- 5 contributing to that minor.
- 6 Q Okay. So you could not exclude William Troy's
- 7 blood on the gun, is that correct?

Any other matters that need to be addressed?

Counsel, I have created draft jury instructions. They contain the standard instructions on justifiable use of nondeadly and necessity. It is a novel. It is about 40 pages long because I did include one of each for each count as you had done in your submission via e-mail.

I have not included any other language that is not standard because what I assumed that what you had wanted that wasn't standard was very short and could be added very quickly.
